Clarifications and responses:

1. The participants wanted to clarify whether instructions will be given to the concerned hospitals authorities in advance to avoid any delay in the installation of the display boards.

It was clarified that necessary instructions will be given to the concerned hospital authorities through State Health Society (SHS) officials to avoid any delay in the installation

of the display boards. Also it was clarified that the schedule received from the consultant firm will be shared to the concerned hospital authorities and suitable instructions will be given to locate the place for erection of display boards in advance and they will be instructed to make the necessary stock entry and issue the acknowledgement in the same day itself to the firm for the installation of the display boards.

2. The participants wanted to clarify whether 75 days scheduled for supply of 50% of the tender quantity of the display boards included holidays also.

It was clarified that 75 days scheduled for supply of 50% of the tender quantity of the display boards is inclusive of all holidays.

3. The participants wanted to clarify about the technical specification of the poles which have to be erected for displaying in the display boards.

It was clarified that 18 gauge 1" X 1" M.S Square hollow pipes for frame work and 2mm thickness heavy 3" Dia.M.S round pipe should be used for the erection of the display boards and joints in the round pipes (poles) are not allowed.

4. The participants wanted to clarify about the warranty of the flex print.

It was clarified that the warranty of the flex print for 1 year will be only for the printing quality and bank guarantee will be retained at TNHSP during the warranty period.

5. The participants wanted to clarify about RCC foundation work which has to be laid for displaying the JSSK boards.

It was clarified that the RCC foundation work which has to be laid for 2½' depth for displaying the JSSK boards has to be in the dimension of size of 2' X 2' X 2½'.

6. The participants wanted to clarify whether payment will be released after the completion of work in all the districts.

It was clarified that payment will be released based on the receipt of acknowledgement from the districts for which work when has been completed. This can be on blocks of 10 districts in one release.

7. The participants wanted to clarify about acknowledgement format for the display work.

It was clarified that the acknowledgement format will have standard details like work completion certificate, Name of the institution, Signature with Designation of the signing authority.

8. The participants wanted to clarify the Rs.1 crore order submitted should be exclusively for display boards alone.

It was clarified that the order for Rs.1 crore submitted should be exclusively for display boards alone and it should not be a portion of other orders like bus shelters displays, bus depots, any other structural works.

9. The participants wanted to clarify whether the 'previous single order worth of Rs.1 Crore for the display boards' as mentioned in bid document have to be submitted from Government or Private Institutions.

It was clarified that the 'previous single order worth of Rs.1 Crore for the display boards' have to be submitted only from State Government / Central Government / Public Sector Companies.

10. The participants wanted to clarify whether the display boards meant other display boards also like Neon Boards, Vinyl Boards, Flex Boards etc.,

It was clarified that other types of display boards except Neon Boards may be specified for the previous orders obtained from Government Institutions.

Finally all the participants were explained that two cover system ("Cover-A", "Cover-B") will have to be followed for submitting the tenders.
