ORDER:

In the Government order read above, orders were issued to accord Administrative Sanction for implementation of Tamil Nadu Road Sector Project-II (TNRSP-II) at an estimated cost of Rs.5,171 Crore, wherein a provision of Rs.120 Crore has been made for Road Safety Component under TNRSP-II. As part of Road Safety initiatives under TNRSP-II, Kancheepuram and Tiruvannamalai Districts have been identified for implantation of Road Safety Components as demonstration districts.

- 2. In continuation of the above, the Project Director, Tamil Nadu Health Systems Project in her letter read above has stated that the proposal for specific investment plan for Health department to strengthen the Trauma Care Services and 108 Ambulance Services in Safe Demonstration Corridor (SDC) incorporating the suggestions given by working Group Committee was approved in the 12th Road Safety Management Cell (RSMC) meeting held on 07.10.2020.
- 3. The Project Director, Tamil Nadu Health System Program has further stated that the proposal to Project Director, TNRSP-II based on their request for ambulances in SDC districts with quantity required and cost estimation of Rs.534.45 lakh for the Government Hospitals and Primary Health Care Centre along the safe Demonstration Corridor. Accordingly, as per the procurement plan, the above proposal has been uploaded in STEP portal and the same was approved by the World Bank and requested the Government to sanction 20 New Ambulances with

Medical equipment at overall cost of Rs.5,34,45,000/-(Rupees Five Crore Thirty Four Lakh and Forty Five Thousand only), the Project Director, TNRSP-II has requested the Managing Director, Tamil Nadu Medical Service Corporation Limited to procure 20 new ambulances along with an equipment to provide Safe Demonstration Corridor.

The abstract of the following vehicles details is given below:-

All the above sequence of procurement process was confirmed by the TNRSP-II and the number of 20 Ambulances were registered in the name of Joint Director of Health Services, Tiruvallur-602 001. The above 20 ambulances have been procured under Road Safety Component of TNRSP-II for the public use and the Hon'ble Chief Minister donated at Rajiv Gandhi Government General Hospital on 14.04.2022.

- 4. As the additional new ambulances received are to be utilized by the service provider M/s GVK EMRI for replacement of existing ambulances which have crossed 6 years of service or 2.5 lakh k.m. whichever is later shall be replaced so as to avoid sudden interruption in service, the additional cost will not be needed will be within operational cost as approved by Government of Tamil Nadu in Budget Estimate 2022-2023.
- 5. The Project Director, Tamil Nadu Health Systems Project & Tamil Nadu Road Sector Project -II has requested the Government to include 20 No's (5 ALS ambulances 15 BLS ambulances) for Safe Demonstration Corridor (SDC) in Kancheepuram, Chengalpattu, Tiruvannamalai and Vellore Districts procured under TNRSP -II funds to add in the existing fleet strength by replacing old vehicles with the new 20 Ambulances under Tamil Nadu Road Sector Project -II fund vehicles on the Safe Demonstration Corridor also to borne the Operational Cost for further usage of Government Emergency Management Services.

- 6. The Government after careful consideration of the proposal of the Project Director, Tamil Nadu Health Systems Project & Tamil Nadu Road Sector Project -II and have decided to permit the Project Director, Tamil Nadu Health Systems Project to accept include 20 No's (5 ALS ambulances + 15 BLS ambulances) for Safe Demonstration Corridor (SDC) in Kancheepuram, Chengalpattu, Tiruvannamalai and Vellore Districts procured under Tamil Nadu Road Sector Project -II funds to add in the existing fleet strength by replacing old vehicles with the new 20 Ambulances under Tamil Nadu Road Sector Project -II fund vehicles on the Safe Demonstration Corridor also to borne the Operational Cost for further usage of Government Emergency Management Services.
