ORDER:

The Hon'ble Minister for Health and Family Welfare has made the following Announcement in the floor of the Tamil Nadu Legislative Assembly during the Demand No.19.

Announcement No.104:-

“திருவண்ணாமலை மற்றும் அரியலூர் அரசு மருத்துவக் கல்லூரி மருத்துவமனை மற்றும் கோவில்பட்டி அரசு மருத்துவமனைகளுக்கு உலக வங்கி திட்டத்தின்கீழ் ரூபாய் 1 கோடி மதிப்பீட்டில் லாப்ரோஸ்கோபிக் கருவிகள் வழங்கப்படும்”.

2. Based on the above announcement, the Project Director, Tamil Nadu Health System Reform Program has sent a letter read above along with the justification, vital statistics and general performance of the Tiruvannamalai Medical College Hospital, Ariyalur Medical College Hospital and Kovilpatti District Head Quarters Hospital (Thoothukudi District) and has requested to provide the Advanced Laparoscopic Set with High-Definition Camera System Gynaecology/General Surgeries to those hospitals.

3. The Project Director, Tamil Nadu Health System Reform Program has worked out the cost involved in the above activity and furnished as follows:-

4. The Project Director, Tamil Nadu Health System Reform Program has stated that the State Empowered Committee had approved the proposal for provision of Advanced Laparoscopic Set with High-Definition Camera System Gynaecology / General Surgeries to Tiruvannamalai Medical College Hospital, Ariyalur Medical College Hospital and Kovilpatti District Head Quarters Hospital (Thoothukudi District) and requested the Government to issue necessary orders in this regard.

5. After careful consideration of the proposal of the Project Director, Tamil Nadu Health System Reform Program, the Government have decided to accept the same and accordingly issue the following orders:-

- (i) (a) Sanction is accorded for a sum of non-recurring expenditure of Rs.66,00,000/- (Rupees Sixty Six lakhs Only) towards the provision of Advanced Laparoscopic Set with High-Definition Camera System Gynaecology/General Surgeries to Tiruvannamalai Medical College Hospital & Ariyalur Medical College Hospital.
- (b) The Director of Medical Education is authorized to draw and deposit the above sanctioned amount into Personal Deposit account of Tamil Nadu Medical Services Corporation Limited.
- (ii) (a) Sanction is accorded for a sum of non-recurring expenditure of Rs.33,00,000/- (Rupees Thirty three lakhs Only) towards the provision of Advanced Laparoscopic Set with High-Definition Camera System Gynaecology/General Surgeries to District Head Quarters Hospital, Kovilpatti, Thoothukudi District.
- (b) The Director of Medical and Rural Health Services is authorized to draw and deposit the above sanctioned amount into Personal Deposit account of Tamil Nadu Medical Services Corporation Limited.
- (iii) A separate SB account to be maintained exclusively for TNHSRP funds in Directorate and facilities involved which should be operated by Joint Signatory.

6. The expenditure sanctioned in para 5 (i) (a) above shall be debited to the following head of account:-
