ORDER:

The Hon'ble Minister for Health and Family Welfare has made the following Announcement in the floor of the Tamil Nadu Legislative Assembly during the Demand No. 19.

(Announcement No. 26) :

“உளுந்தூர்பேட்டை, ஒசூர், ஜெயங்கொண்டம், பொள்ளாச்சி மற்றும் பட்டுக்கோட்டை ஆகிய 5 மாவட்ட மருத்துவமனைகளில் ஒருங்கிணைந்த அவசரிகிச்சை (Trauma Emergency Care Centre) சேவைகளை மேம்படுத்த ரூபாய் 17.07 கோடி செலவில் புதிய கட்டடங்கள் கட்டப்படும்”.

2. Based on the above announcement, the Project Director, Tamil Nadu Health System Reform Program has sent proposal approved by the State Empowered Committee headed by Chief Secretary for the Strengthening of Trauma and Emergency Care at Government Hospital Pattukottai, Thanjavur and stated that to strengthen the trauma and emergency care, the Government of Tamil Nadu has launched Tamil Nadu Accident and Emergency care Initiative (TAEI) Program in 2017 and 82 Government health facilities were designated as TAEI facilities. These TAEI centres are dealing with 6 pillars, namely Trauma, MI, Stroke, Poison, Burns Paediatric Emergencies and other life-threatening conditions. As a front-line face lifting unit in institution, these centres play a major role in quality management and bring down the mortality. Further, gap analysis are being done regularly to identify new centres in the state to upgrade as a TAEI Centre with the provision of Infrastructures like Civil Modifications, Equipments, etc.,

3. The Project Director, Tamil Nadu Health System Reform Program has stated that the Government Hospital, Pattukottai, Thanjavur District is one among them identified for Upgradation as TAEI centre. The Government Hospital is covering 1,00,000 population with-in the town and 1,00,000 population from surrounding areas. It is located in the Major state Highway and 50 Km away from the Govt. Medical College Hospital, Thanjavur. Any emergency cases including Trauma from within the town and from the surrounding areas are reported to this centre, as it is located strategically. Due to lack of infra-structure, the cases are being shifted to the Medical college which takes the travelling time more than an one hour which lead to losing the advantage of Golden hour to save the life.

4. The Project Director, Tamil Nadu Health System Reform Program has furnished the vital statistics relates to Government Hospital Pattukottai as follows:-

6. The Project Director, Tamil Nadu Health System Reform Program has requested the Government to issue necessary orders in this regard.

7. The Government after careful consideration of the proposal of the Project Director, Tamil Nadu Health System Reform Program have decided to accept the same and accordingly issue the following orders:-

- i. Sanction is accorded for a sum of Rs.98,36,470/-(Rupees Ninety Eight Lakh, Thirty Six Thousand, Four Hundred and Seventy only) to Director of Medical and Rural Health Services towards the Strengthening of Trauma and Emergency Care in Government Hospital, Pattukottai, Thanjavur District as detailed below:-
 1. Civil - Rs.30,00,000/-
 2. Equipments - Rs.66,36,470/-
 3. Operational Cost - Rs.2,00,000/-
- ii. The Director of Medical and Rural Health Services is permitted to do Minor Civil Modification of Trauma and Emergency Care Center through the Public Works Department (PWD) at the cost of Rs.30,00,000/- (Rupees Thirty Lakh only) and to procure the equipments at the cost of Rs.66,36,470/- through Tamil Nadu Medical Services Corporation as annexed to this Government Order for Government Hospital, Pattukottai, Thanjavur District.
- iii. The Director of Medical and Rural Health Services is authorized draw and disburse the above amount.
- iv. The Director of Medical and Rural Health Services is permitted to draw and deposit the amount sanctioned for equipment into Personal Deposit account of Tamil Nadu Medical Services Corporation.

8. The above said amount shall be met out from the existing budget provision of RBE 2021-2022.

9. The expenditure sanction in para 7 (i) above shall be debited to the following head of account respectively:-
