## ORDER:

The Project Director, Tamil Nadu Health System Reform Program has stated that the Modern Contraception Usage at Reproductive age (15-49 years) are as follows:

As per World Bank, increased usage of modern contraceptive methods needs to be done. Modern methods include male and female sterilization, injectables, IUDs/PPIUCDs, contraceptive pills, implants, female and male condoms, diaphragm, foam/jelly, the standard days method, the lactational amenorrhoea method and emergency contraception.

2. The Project Director, Tamil Nadu Health System Reform Program has stated that based on the NFHS 4 result, the following districts have been identified as priority districts:

The Project Director, Tamil Nadu Health System Reform Program has also proposed to carry out the following activity for strengthening of usage of modern contraceptive methods in the 10 priority districts by Directorate of Family Welfare, 36 institutions have been selected out of 65 Secondary and Tertiary institutions in the 10 priority districts. The 36 (9 MCH, 5 DHQH and 22 SDH) institutions selected are based on number of deliveries more than 25 per month. The post-partum counsellors are sanctioned in 33 institutions (except Palacode, Pennagaram, Thiruthangal hospitals) and the proposal was approved by the State Empowered Committee in the 3<sup>rd</sup> meeting of the State Empowered Committee.

- 5. The Project Director, Tamil Nadu Health System Reform Program has requested the orders of the Government in this regard.
- 6. The Government after careful consideration of the proposal of the Project Director, Tamil Nadu Health System Reform Program have decided to accept the same and accordingly issue the following orders:
  - i. Sanction is accorded for a sum of non-recurring expenditure of Rs.23,04,000/(Rupees Twenty Three Lakh and Four Thousand only) to Director of Family
    Welfare towards setting up Family welfare Help Desk at 9 Medical College
    Hospitals and in 27 Sub district/District Hospitals in 10 priority districts (list
    mentioned at para 2) with more than 25 deliveries per month and with in-position
    post-partum counselors.
  - ii. The Director of Family Welfare is permitted to draw and utilize the amount sanctioned at para 6 (i) above through DDFW of concerned Districts, pending provision of funds under RE for the year 2021-2022.
  - iii. A separate account to be maintained exclusively for Tamil Nadu Health System Reform Program funds in Directorates, Districts and Facilities (till beneficiary level if needed) involved, which should be operated by Joint Signatory.
  - iv. The expenditure sanctioned in para 6(i) above shall be debited under the following head of account:-
    - "2210 Medical and Public Health 01 Urban Health Services Allopathy 110 Hospitals and Dispensaries Externally Aided Project PH Tamil Nadu Health Systems Reform Project Administered by Director of Family Welfare 309 Grants in Aid 03 Grants for Specific Schemes
