ORDER:

The Hon'ble Minister for Health and Family Welfare has made the following Announcement in the floor of the Tamil Nadu Legislative Assembly during the Demand No.19.

Announcement No.17:-

“சென்னை – ராஜீவ்காந்தி அரசு பொது மருத்துவமனையில், பொது மக்கள் சிறந்த மருத்துவ சேவையை பெறுவதற்காக, நவீன உபகரணங்களுடன் புதிய நரம்பியல் பிரிவு கட்டடம் ரூபாய் 65 கோடி மதிப்பீட்டில் கட்டப்படும்.”

2. Based on the above announcement, the Project Director, Tamil Nadu Urban Healthcare Project in her letter first read above, has initiated to accord administrative and financial sanction for a sum of Rs.64,93,84,000/-towards the construction of a new building with equipment for the Neuro Science Block at Rajiv Gandhi Government General Hospital, Chennai. In the midst of the consideration of the above, the Project Director, Tamil Nadu Urban Healthcare Project has reported in the meeting held on 24.08.2022 that, it has been decided to provide a new building with equipment to the Neuro Science Block in Rajiv Gandhi Government General Hospital from the Tamil Nadu Health System Reform Program funds instead of JICA funds due to administrative reasons.

3. Subsequently, the Project Director, Tamil Nadu Health Systems Project in her letter second read above has stated that, as JICA savings funds finalization and approval will take time, as per the PSC meeting under the chairmanship of the Principal Secretary, Health and Family Welfare, funds may be booked in Tamil Nadu Health System Reform Program and proposed to construct a Neuro Science Block at

Rajiv Gandhi Government General Hospital, Chennai from out of savings from JICA project at a cost of Rs.65.00 Crore was approved by the State Empowered Committee as Proposal No:30/2022 has been revised as the proposal from JICA funds to Tamil Nadu Health System Reform Program funds. She has requested the Government to issue the orders in this regard and furnished her justification in this activity and furnished the above said activity works out to Rs.65.00 Crores as follows:-

4. After careful consideration of the request of the Project Director, Tamil Nadu Health System Reform Program, the Government have decided to accept the same as per the actual estimate and accordingly issue the following orders:-

- Sanction is accorded for a sum of Rs.60,00,00,000/- (Rupees Sixty Crore only) for the construction of a Neuro Science Block in Rajiv Gandhi Government General Hospital, Chennai through Public Works Department.
- Sanction is accorded for a sum of Rs.4,93,84,000/- (Rupees Four Crore Ninety three lakh and eighty four thousand only) towards Medical Gas Pipeline System and Medical Equipment to the above said Neuro Science Block through the Tamil Nadu Medical Services Corporation Ltd.
- The Director of Medical Education is authorized to draw and disburse the amount sanctioned at para 4(i)&(ii) above.
- A separate account to be maintained exclusively for Tamil Nadu Health System Reform Program funds in both Directorates and Facilities involved, which should be operated by joint signatory.

5. The expenditure sanctioned in para 4 (i) above shall be debited to the following head of account:-

4210 – Capital Outlay on Medical and Public Health - 01 Urban Health Services – 200 Other Health Schemes - Externally Aided Projects – PC - Tamil Nadu Health System Reforms Projects – 416 Major Works – 01 Major Works.

6. The expenditure sanctioned in para 4 (ii) above shall be debited to the following head of account:-

2210-Medical and Public Health-01 Urban Health Services – Allopathy – 110 Hospitals and Dispensaries – Externally Aided Projects - PE, Tamil Nadu Health System Reforms Project – Administred by the Director of Medical Education - 319 Machinery and Equipments – 01 Purchase

7. The expenditure sanctioned in para-4 above shall constitute an item of "New Instrument of Service" and the approval of Legislature will be obtained in due course. Pending approval of the Legislature, the expenditure may be initially met by drawal of an advance from the Contingency Fund. The Director of Medical Education is directed to calculate the actual amount required for the period upto next Supplementary Estimates and apply for sanction of the same as advance from the Contingency Fund to Finance (BG.I) Department directly in Form A appended to the Tamil Nadu Contingency Fund Rules 1963 along with a copy of this order. Orders for sanction of an advance from the Contingency Fund will be issued from Finance (BG.I) Department. The Director of Medical Education is requested to send necessary explanatory notes to include the above expenditure in the Supplementary Estimates for the year 2022-2023 to Finance (Health-II / BG-I) Department at the appropriate time without fail.

8. The Director of Medical Education is authorized to draw and deposit the sanctioned amount at para 4(ii) into the personal deposit account of Tamil Nadu Medical Services Corporation Limited, Chennai for the procurement of equipment through the Tamil Nadu Medical Services Corporation Limited, Chennai.

9. This order issues with the concurrence of the Finance Department vide its U.O.No.46727/Finance (Health-II)/2022, Dated:28.10.2022 and ASL No.1638 (one thousand six hundred and thirty eight) (IFHRMS ASL No.2022101638).
