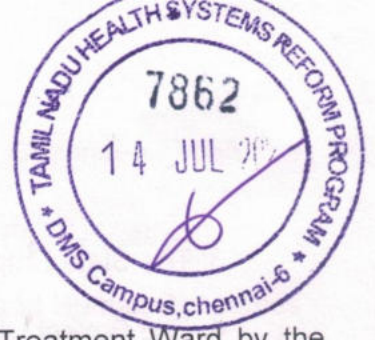

ORDER:

The Hon'ble Minister for Health and Family Welfare has made the following Announcement in the floor of the Tamil Nadu Legislative Assembly during the Demand No.19.

Announcement No.8:

"தஞ்சாவூர் அரசு மருத்துவக்கல்லூரி மருத்துவமனைக்கு விஷமுறிவு சிகிச்சைக்கான Plasmapheresis உபகரணம் வழங்கப்படும். மேலும், கோவை அரசு மருத்துவக்கல்லூரி மருத்துவமனையில் விஷமுறிவு அவசர சிகிச்சைக்கான மாநில பயிற்சி மையம் அமைக்கப்படும். பாம்புக்கடி நஞ்சுமுறிவு சிகிச்சைக்கான பயிற்சிகள் மாநில அளவில் மருத்துவப்பணியாளர்களுக்கு வழங்கப்படுவதோடு, அனைத்து கிராமங்களிலும் தன்னார்வலர்களுக்கு முதலுதவி பயிற்சிகள் வழங்கப்படும்".

2. The Project Director, Tamil Nadu Health System Reform Program in the letter read above has furnished the General Information, CMCHIS performance and poisoning cases reported at the Medical College Hospital, Thanjavur and justified to procure the Cell Separator Unit for Plasmapheresis to the institution with the estimated budget as follows:-

3. The State Empowered Committee has approved the above proposal.

4. The Project Director, Tamil Nadu Health System Reform Program therefore has requested the Government to issue necessary orders in this regard.

5. After careful consideration of the proposal of the Project Director, Tamil Nadu Health System Reform Program, the Government have decided to accept the same and accordingly issue the following orders:-

- (i) Sanction is accorded for a sum of Rs.33,15,547/- (Rupees Thirty Three Lakh Fifteen Thousand Five Hundred and Forty Seven only) towards the provision of Cell Separator unit for Plasmapheresis at Thanjavur Medical College and Hospital under the State share of Tamil Nadu Health System Reform Program.
- (ii) The Director of Medical Education and Research is authorized to draw the above sanctioned amount towards the procurement of Cell Separator through Tamil Nadu Medical Services Corporation Limited.
- (iii) A separate account to be maintained exclusively for Tamil Nadu Health System Reform Program funds in Directorates, Districts and Facilities (till beneficiary level if needed) involved, which should be operated by Joint Signatory.

6. The expenditure sanctioned in para 5 (i) above shall be debited to the following head of account:-

2210 – Medical and Public Health – 01 Urban Health Services - Allopathy –
110 Hospitals and Dispensaries – Externally Aided Projects – PE –
Tamil Nadu Health System Reform Project – Administred by the Director of
Medical Education – 319 Machinery and Equipments – 01Purchase
(DPC 2210 - 01-110 - PE-31901)

7. Necessary funds of Rs.33,15,547/- will be provided in Revised Estimate / Final Modified Appropriation 2023-2024. Pending provision of such funds, the Director of Medical Education and Research is authorized to draw and disburse the above sanctioned amount. However, this expenditure shall be brought to the notice of the Legislature by Specific Inclusion in the Supplementary Estimates 2023-2024. The Director of Medical Education and Research is also requested to include this expenditure while sending the budget proposals for Revised Estimate / Final Modified Appropriation 2023 - 2024 and also send draft explanatory notes for inclusion of this expenditure in the Supplementary Estimates 2023-2024 to Government in Finance (BG-I/ Health-II) Department at an appropriate time without fail.

8. This order issues with the concurrence of the Finance Department vide its U.O.No.25843/Health-II/2023, Dated: 10.07.2023 and ASL No.484 (Four Hundred and Eighty Four) (IFHRMS ASL No.2023070484).
