- 3. The Project Director, Tamil Nadu Health System Reform Program has stated that the State Empowered Committee had approved the proposal and has requested the Government to issue necessary orders in this regard.
- 4. After careful consideration of the proposal of the Project Director, Tamil Nadu Health System Reform Program, the Government have decided to accept the same and accordingly issue the following orders:-
  - Sanction is accorded for a sum of Rs.25,80,000/- (Rupees twenty five lakh and eighty thousand only) towards sensitization, implementation and monitoring of facility level quality committees.
  - (ii) Sanction is accorded for a sum of Rs.8,58,000/- (Rupees Eight lakhs and fifty eight thousand only) towards implementation of facility level quality committee in 143 facilities as mentioned in annexure-1 to this order.
  - (iii) Sanction is accorded for a sum of Rs.7,44,000/- (Rupees Seven lakh and forty four thousand only) towards implementation of facility level quality committee in 62 facilities as mentioned in annexure-2 to this order.
  - (iv) The Project Director, Tamil Nadu Health System Reform Program is authorised to draw and utilize the amount sanctioned in para 4(i) above.
  - (v) The Director of Public Health and Preventive Medicine is authorised to draw and utilize the amount sanctioned in para 4(ii) above.
  - (vi) The Director of Medical and Rural Health Services is authorised to draw and utilize the amount sanctioned in para 4(iii) above.
