ORDER:

The Hon'ble Minister for Health and Family Welfare has made the following announcement in the floor of the Tamil Nadu Legislative Assembly during the Demand No.19.

Announcement No:27:-

"சென்னை அரசினர் சித்த மருத்துவக்கல்லூரி மருத்துவமனையில் கூடுதல் கட்டமைப்பு வசதிகள் ரூபாய் 5.09 கோடி மதிப்பீட்டில் அமைக்கப்படும்".

2. Based on the above, the Project Director, Tamil Nadu Health System Reform Program has sent a proposal wherein it has been stated that the Government Siddha Medical College, Arumbakkam, Chennai is one of the oldest Siddha Medical College in the country established in the year 1985 which provides specialty Siddha Medical Care to the patients from Chennai and neighbouring districts. The Medical College is now functioning with 156 beds and the number of patients seeking Siddha treatment has been increasing yearly. Hence, improving the infrastructure of the PG Block will improve the quality of education and thereby improve patient care to the poor patients who are in need of it.

3. The Project Director, Tamil Nadu Health System Reform Program has further stated that from the year 2016 onwards, the annual intake of students in the Government Unani Medical College, Chennai is increased to 60 and the admission of number of female students is also increased. Due to the shortage of space, some students are being accommodated in the Floor above the Siddha Hospital ward. The female students enrolling for UG and PG has been increasing, more rooms are required in the Ladies Hostel. Based on the above reasons and necessity, additional accommodation is very essential for the benefit of the female students to avoid overcrowding. He has furnished additional particulars of the General performance and

Human Resources of the Government Siddha and Unani Medical Colleges it is furnished the justification to take up the activity towards the construction of Academic and Hostel building along with equipment and construction plan to Government Siddha and Unani Medical College, Arumbakkam, Chennai. The Non-recurring cost involved in the above proposal is furnished as follows:-

4. The State Empowered Committee has approved the above proposal.

5. The Project Director, Tamil Nadu Health System Reform Program therefore requested the Government to issue the orders in this regard and to sanction out of Rs.5,09,00,000/- the amount of Rs.1,40,00,000/- for this Financial year 2023-2024 and the balance amount of Rs.3,69,00,000/- for next Financial year 2024-2025.

6. The Government, after careful examination, have decided to accept the proposal of the Project Director, Tamil Nadu Health System Reform Program and accordingly issue the following orders:-

- i. An administrative sanction is accorded for a sum of Rs.5,09,00,000/- towards execution for construction of Academic and Hostel Building along with equipment to Government Siddha Medical College, Arumbakkam, Chennai.
- ii. A financial sanction is accorded for the non-recurring expenditure of Rs.50,00,000/- (Rupees fifty lakh only) for this financial year 2023-2024 and balance amount will be sanctioned in the next Financial year 2024-2025 towards the construction of additional floor in PG Academic Block at Government Siddha Medical College, Arumbakkam, Chennai through Public Work Department.
- iii. A financial sanction is accorded for the non-recurring expenditure of Rs.60,00,000/- (Rupees sixty lakh only) for this financial year 2023-2024 and balance amount will be sanctioned in the next Financial year 2024-2025 towards the construction of additional floor in the Ladies hostel at Government Siddha Medical College, Arumbakkam, Chennai through Public Work Department.
- iv. A financial sanction is accorded for the non-recurring expenditure of Rs.15,00,000/- (Rupees fifteen lakh only) towards the minor civil works at Government Unani Medical College, Arumbakkam, Chennai through Public Work Department.
- v. A financial sanction is accorded for the non-recurring expenditure of Rs.15,00,000/- (Rupees fifteen lakh only) towards the purchase of equipment at Government Siddha Medical College, Arumbakkam, Chennai through Tamil Nadu Medical Services Corporation.
- vi. The Director of Indian Medicine and Homeopathy is permitted to draw and disburse the amount sanctioned in para 6 (ii), (iii), (iv) and (v) above.

- vii. A separate account to be maintained exclusively for Tamil Nadu Health System Reform Program funds in Directorates, involved, which should be operated by Joint Signatory.

7. The expenditure sanctioned in para 6 (ii) and (iii) above shall be debited to the following head of account:-

4210-Capital Outlay on Medical and Public Health – 03 Medical Education Training and Research -104 Siddha –State's Expenditure – JA Buildings – 416 Major Works-01-Major Works

8. The expenditure sanctioned in para 6 (iv) above shall be debited to the following head of account:-

2059- Public Works – 01 Office Buildings -053 Maintenance and Repairs – State's Expenditure BX Buildings – Indian Medicine and Homeopathy (Administered by Chief Engineer (Buildings)) 317 Minor Works 01 Minor Works.

9. The expenditure sanctioned in para 6 (v) above shall be debited to the following head of account:-

2210 – Medical and Public Health – 05 Medical Education Training and Research – 104 Siddha-State's Expenditure – AC-Government Siddha Medical Colleges – 319 – Machinery and Equipments - 01 - Purchase.

10. Necessary additional funds of Rs.1,40,00,000/- will be provided in Revised Estimate/Final Modified Appropriation 2023-2024. Pending provision of such funds, the Engineer in Chief (Buildings) and Chief Engineer (General), Public Works Department/ Director of Indian Medicine & Homeopathy is authorized to draw and disburse the above sanctioned amount. However, this expenditure shall be brought to the notice of the Legislature by Specific Inclusion in the Supplementary Estimates 2023-2024. The Engineer in Chief (Buildings) and Chief Engineer (General), Public Works Department / Director of Indian Medicine & Homeopathy is also requested to include this expenditure while sending the budget proposals for Revised Estimate / Final Modified Appropriation 2023 - 2024 and also send draft explanatory notes for inclusion of this expenditure in the Supplementary Estimates 2023-2024 to Government in Finance (BG-I/Health-II) Department at an appropriate time without fail.


