ORDER:

The Hon'ble Minister for Health and Family Welfare has made the following Announcement in the floor of the Tamil Nadu Legislative Assembly during the Demand No.19.

Announcement No.78:

"மூன்று அரசு மருத்துவக் கல்லூரி மருத்துவமனைக்கு லேப்ரோஸ்கோபி, ப்ரோன்கோஸ்கோயி, எலும்பு மற்றும் தண்டுவட அறுவை சிகிச்சைக்கான உபகரணங்கள் மற்றும் இரத்த சேமிப்பு அலகிற்கான உபகரணங்கள் நேபாய் 1.58 கோடி மகிப்பீட்டில் வழங்கப்படும்."

2. One among the three Medical College Hospitals in the above, the announcement relates to the Chengalpattu Medical College Hospital as follows:-

"தமிழ்நாடு சுகாதார சீரமைப்புத் திட்டத்தின் கீழ், செங்கல்பட்டு அரசு மருத்துவக் கல்லூரி மருத்துவமனைக்கு ஏழை எளிய மக்கள் பயன் பெறும் வகையில், ரூ.0.65 கோடி மதிப்பீட்டில் அதிநவீன லேப்ரோஸ்கோபி & ப்ரோன்கோஸ்கோபி மருத்துவக் கருவிகள் வழங்கப்படும்."

3. Based on the above, the Project Director, Tamil Nadu Health System Reform Program in the letter read above has sent a proposal towards the provision of Laparoscopy & Bronchoscopy to the Government Medical College Hospital Chengalpattu at a cost of Rs.65.00 lakhs along with the statistical reports of the institution and justification for the requirement of the equipment in the estimated budget as follows:-

- 4. The State Empowered Committee has approved the above proposal.
- 5. The Project Director, Tamil Nadu Health System Reform Program therefore has requested the Government to issue necessary orders in this regard.
- 6. After careful consideration of the proposal of the Project Director, Tamil Nadu Health System Reform Program, the Government have decided to accept the same and accordingly issue the following orders:-
 - Sanction is accorded for a sum of Rs.65,00,000/- (Rupees sixty five lakh only) towards the procurement of Advanced Laparoscopy set with Accessories and Video Bronchoscopy to Chengalpattu Medical College Hospital, Chengalpattu District.
 - ii. The Director of Medical Education and Research is authorized to draw the amount sanctioned above and deposit the same in to the Personal Deposit account of the Managing Director Tamil Nadu Medical Services Corporation Limited so as to procure the equipment.
- 7. The expenditure sanctioned in para 6 (i) above shall be debited to the following head of account:-

2210 - Medical and Public Health - 01 Urban Health Services - Allopathy - 110 Hospitals and Dispensaries - Externally Aided Projects - PE - Tamil Nadu Health System Reform Project - Administrated by the Director of Medical Education - 319 Machinery and Equipments - 01 Purchase

- 8. Necessary funds of Rs.65,00,000/- will be provided in Revised Estimate/ Final Modified Appropriation 2023-2024. Pending provision of such funds, the Director of Medical Education and Research is authorized to draw and disburse the above sanctioned amount. However, this expenditure shall be brought to the notice of the Legislature by Specific Inclusion in the Supplementary Estimates 2023-2024. The Director of Medical Education and Research is also requested to include this expenditure while sending the budget proposals for Revised Estimate / Final Modified Appropriation 2023-2024 and also send draft explanatory notes for inclusion of this expenditure in the Supplementary Estimates 2023-2024 to Government in Finance (BG-I/ Health-II) Department at an appropriate time without fail.
- 9. This order issues with the concurrence of the Finance Department vide its U.O.No.25847/Health-II/2023, Dated:12.07.2023 and ASL No.500 (Five Hundred) (IFHRMS ASL No.2023070500).
