ORDER:

In the Government Order first read above, orders have been issued for accorded administrative sanction for Rs.35.63 Crores towards Demolition of old buildings and construction of new buildings at Government Siddha Medical College, Palayamkottai based on the announcement made by the Hon'ble Minister for Finance and Human Resources Management during the budget speech 2023-2024.

2. In the Government Order second read above, financial sanction has been accorded for a sum of Rs.1.00 Crore for the above work for the year 2024-2025. The above sanctioned amount Rs.1,00,00,000, which was released in RE/FMA 2024-2025 was not incurred by the Public Works Department during 2024-2025 and the amount lapsed into the Government account at the end of the Financial Year.

3. In the letter third read above, the Project Director, Tamil Nadu Health Systems Project has requested to issue financial sanction for the remaining amount of Rs.34.63 Crore based on the orders issued in G.O.Ms.No.59, Health and Family Welfare (EAP-I) Department, dated 06.03.2024 to facilitate early execution of the proposed civil work at Government Siddha Medical College, Palayamkottai through Public Works Department.

4. The Government, after careful examination, issue the following orders:-

- i. an administrative sanction of Rs.34,63,40,000/- and financial sanction for Rs.27,85,05,000/- (Rupees twenty seven crore eighty five lakhs and five thousand only) is accorded towards demolition of old building and construction of new buildings for OP Block with equipment, Academic

Block, Gents Hostel at Government Siddha Medical College, Palayamkottai through Public Works Department.

ii. the Commissioner of Indian Medicine and Homeopathy is permitted to draw and disburse the amount sanctioned in para. 4(i) above.

iii. the Commissioner of Indian Medicine and Homeopathy is requested to instruct the Public Works Department to submit the monthly expenditure statement.

5. The expenditure sanctioned in para 4(i) above shall be debited to the following head of account:-

4210 - Capital Outlay on Medical and Public Health - 03 Medical Education Training and Research - 104 Siddha - State's Expenditure - JC Construction of Buildings at Government Siddha Medical College, Palayamkottai - 416 Major works - 01 Major works"

6. Necessary fund of Rs.27,85,05,000/- has already been provided in RE 2025-2026 under the HoA "4210 03 104 JC 41601" for the construction of Buildings at Government Siddha Medical College, Palayamkottai. The Commissioner of Indian Medicine and Homeopathy is authorised to draw and disburse the amount sanctioned in para 4 above.
