- -6. The Project Director, Tamil Nadu Health System Reform Program has requested the orders of the Government on the following:-
  - To sanction a non recurring expenditure of Rs. 4,98,68,000/- to the Directorate of Public Health and Preventive Medicine towards procurement of Desktops with UPS and Printer through ELCOT in 548 primary care institutions as in annexure.
  - ii. To sanction a non recurring expenditure of Rs. 66,43,000/- to the DMS towards procurement of Desktops with UPS and Printer through ELCOT in 73 secondary care institutions as in annexure.
  - iii. To sanction a non recurring expenditure of Rs.8,19,000/- to the Director of Medical Education towards procurement of Desktops with UPS and Printer through ELCOT in 9 territory care institutions as in annexure.
  - iv. To permit the Directorate of Public Health and Preventive Medicine to draw and utilize the amount as sanctioned in para 6(i) above.
  - v. To permit the Director of Medical and Rural Health Services to draw and utilize the amount as sanctioned in para 6(ii) above.
  - vi. To permit the Director of Medical Education to draw and utilize the amount as sanctioned in para 6(iii) above.
- vii. A separate account to be maintained exclusively for Tamil Nadu Health System Reform Program funds in Directorates, Districts and Facilities (till beneficiary level if needed) involved, which should be operated by Joint Signatory.
- 7. The Government after careful consideration of the proposal of the Project Director, Tamil Nadu Health System Reform Program have decided to accept the same and accordingly issue the following orders subject to the condition that the concerned bulk purchase of software should be made at the lowest price available for Government Organizations / Non-Profit / Educational Institutions etc., so as to be cost effective:
  - i. Sanction is accorded for a sum of Rs.4,98,68,000/- (Rupees Four crore ninety eight lakh sixty eight thousand only) to the Directorate of Public Health and Preventive Medicine towards procurement of Desktops with UPS and Printer through ELCOT in 548 primary care institutions as in annexure.
  - ii. Sanction is accorded for a sum of Rs.66,43,000/- (Rupees Sixty six lakh forty three thousand only) to the Director of Medical and Rural Health Services towards procurement of Desktops with UPS and Printer through ELCOT in 73 secondary care institutions as in annexure.
  - iii. Sanction is accorded for a sum of Rs.8,19,000/- (Rupees eight lakh nineteen thousand only) to the Director of Medical Education towards procurement of Desktops with UPS and Printer through ELCOT in 9 territory care institutions as in annexure.
  - iv. The Directorate of Public Health and Preventive Medicine is permitted to draw and utilize the amount as sanctioned in para 6 (i) above.
  - v. The Director of Medical and Rural Health Services is permitted to draw and utilize the amount as sanctioned in para 6 (ii) above.
  - vi. The Director of Medical Education is permitted to draw and utilize the amount as sanctioned in para 6 (iii) above.

- vii. A separate account to be maintained exclusively for Tamil Nadu Health System Reform Program funds in Directorates, Districts and Facilities (till beneficiary level if needed) involved, which should be operated by Joint Signatory.
- 8. The expenditure sanctioned in para 7 (i) above shall be debited under the following head of account:-
  - "2210 Medical and Public Health 01 Urban Health Services Allopathy 200 other Schemes Externally Aided Project PB Tamil Nadu Health Systems Reform Project Administrated by Director of Public Health 309 Grants-in-Aid 03 Grants for Specific Schemes" (IFHRMS DPC 2210-01-200-PB-30903)
- 9. The expenditure sanctioned in para 7 (ii) above shall be debited under the following head of account:-
  - "2210 Medical and Public Health 01 Urban Health Services Allopathy 110 Hospitals and Dispensaries -Externally Aided Project PD Tamil Nadu Health Systems Reform Project Administrated by the Director of Medical and Rural Health Services 309 Grants-in-Aid 03 Grants for Specific Schemes" (IFHRMS DPC 2210-01-110-PD-309 03)
- 10. The expenditure sanctioned in para 7 (iii) above shall be debited under the following head of account:-
