ORDER:

In Government Order first read above, among others, the Government have accorded administrative sanction for the implementation of Tamil Nadu Urban Health Care Project components viz., Upgrading Tertiary Hospitals, Strengthening Referral and Secondary care Hospitals, Strengthening Hospital Management and Primary Health Care in Non-Communicable Diseases at a total cost of Rs.1634,69,50,000/- with the assistance of Japan International Co-operation Agency (JICA).

- 2. In Government Order second read above, the State Empowered Committee (SEC) for the Tamil Nadu Urban Health Care Project has been formed under the Chairmanship of the Chief Secretary to Government. In the said Government Order, the Government have further ordered that, the State Empowered Committee shall meet periodically at every six months and also shall meet in between six months based on the requirement. In urgency, the proposal can be circulated among the members and get approved. The decision of the State Empowered Committee shall be communicated as Government orders from the Health and Family Welfare Department. The financial powers of the State Empowered Committee shall be upto Rs. 5.00 crore for civil works, equipment and for services.
- 3. In Government Order third read above, among others, the Government have approved the Change of the Location for construction of a Secondary Care Hospital from the originally planned Maniyanoor in Salem Corporation Area to Ammapettai in Salem Corporation Area in view of the difficulties existing in the original site at Maniyanoor. Further in the said Government Order the Government have sanctioned a sum of Rs.8,29,37,625/-(Rupees Eight crore Twenty nine lakh Thirty Seven thousand Six hundred and Twenty Five only) for procurement of land in the newly proposed site at Ammapettai to the extent of 4600sq.mtrs at a cost of Rs.1675 per sq. ft for the purpose of construction of a secondary care hospital under Tamil Nadu Urban Health Care Project.
- 4. Now, the Project Director, Tamil Nadu Urban Health Care Project in her letter fourth read above has stated that, it is proposed to provide Modular Operation Theatres and Medical Gas Pipeline System to the following four secondary care hospitals where new

buildings are being constructed and nearing completion under component 3 of the Tamil Nadu Urban Health care Project (TNUHP) namely,

- (i) Government Hospital Avadi (Tiruvallur District),
- (ii) Government Hospital Velampalayam (Tirupur District),
- (iii) Government Hospital Kandiyaperi (Tirunelveli District) and
- (iv) Government Hospital Ammapet (Salem District)

She has further stated that, during the meeting held under the chairmanship of the Principal Secretary/OSD, it has been concluded to vest the administrative control of the project hospitals to the Directorates of the Health and Family Welfare department as detailed below:

*Since Velampalayam (Tiruppur District) is a standalone new Secondary care facility under Japan International Co-operation Agency, developed with 3 Operation Theatres and 60 bedded (G+3) building, Director of Medical and Rural Health Services may be permitted to propose additional Human Resources after completion.

5. The Project Director, Tamil Nadu Urban Health Care Project has further stated that, the procedure for claims approved and reimbursement by Japan International Co-operation Agency is too lengthy and time consuming. Hence the present proposal at this stage will be ideal, so that supply of equipment will be on par with civil work completion and hospital can be made functional immediately to the general public. She has also stated that, the building construction is progressing as per schedule and will be handed over at the end of September 2022 except Ammapet which will be handed over at the end of February 2023 as building construction started late. She has stated that the Japan International Co-operation Agency.

India Office has approved the revised equipment list proposed for component 3.2 under the captioned project. In view of the above, the proposal for providing Modular Operation Theatres and Medical Gas Pipeline System to the four secondary care hospitals at Avadi, Velampalayam, Kandiyaperi and Ammapet was circulated to State Empowered Committee chaired by the Chief Secretary to the Government and the same was approved by State Empowered Committee on 10.03.2022. Hence, the Project Director, Tamil Nadu Urban Health Care Project has requested the Government to issue necessary orders in this regard.

- 6. The Government have examined the proposal of the Project Director, Tamil Nadu Urban Health Care Project in detail and accordingly, do and hereby issue the following orders:-
- i. The Project Director, Tamil Nadu Urban Healthcare Project is permitted to incur a non recurring expenditure of Rs. 15,80,24,448/- (Rupees Fifteen Crore Eighty Lakh Twenty Four Thousand Four Hundred and Forty Eight only) towards the provision of Modular Operation Theatres and Medical Gas Pipeline System to the four Government Hospitals at Avadi-Tiruvallur, Velampalayam-Tiruppur, Kandiyaperi-Tirunelveli and Ammapet-Salem through Public Works Department by following Japan International Co-operation Agency procurement guidelines as detailed below:

The Project Director, Tamil Nadu Urban Healthcare Project is permitted to transfer INR Rs.15,80,24,448/- (Rupees Fifteen Crore Eighty Lakh Twenty Four Thousand Four Hundred and Forty Eight only) to the Public Works Department through the existing system towards the procurement of the following items as per Japan International Co-operation Agency procurement guidelines.

- iv. The Engineer-in-Chief and Chief Engineer (Buildings), Public Works Department is directed to procure the above items by following Japan International Co-operation Agency Procurement Guidelines, bidding procedures and supply and installation of Operation Theatres and Medical Gas Pipeline System in the concerned institutions and to settle the account with the Project Director, Tamil Nadu Urban Healthcare Project on completion of the activity.

The Project Director, Tamil Nadu Urban Healthcare Project is permitted to increase or decrease the number of items as per need within the overall non recurring cost sanctioned for this activity and to revise the technical specifications with the concurrence of Japan International Co-operation Agency if required.
