Welfare of Differently Abled Persons Department- Approval for attaching the 32 Mobile Therapy Units with Indian Red Cross Society (IRCS) for the limited purpose of maintenance of the fleet and operations-Administrative sanction - Orders- Issued.

ORDER:

In the Government Order first read above, orders were issued for launching Mobile Therapy Units for the welfare of the differently abled children in the age group of 0-6 years in all 32 Districts from the year 2013-2014 and also sanctioned a sum of Rs.4,49,00,000/-.

- 2. In the Government Order second read above, orders were issued for the continuance of operating Mobile Therapy Units for the age group of 0-6 Differently Abled children in all 32 Districts and Rs.38,12,000/- was also sanctioned.
- 3. In the D.O. letter fourth read above, the State Commissioner for the Differently Abled, has sent a proposal based on the proposal of the Project Director, Tamil Nadu Health System Project to Government stating that, there are 32 Mobile Therapy Units with the department, one in each District for attending to the Differently Abled Children in 0-6 age group in rural areas and remote places of each District. The State Commissioner for the Differently Abled has informed that the Project Director has stated that under Janani Shishu Suraksha Karyakram, being implemented by the Tamil Nadu Government, fleet of vehicles is being maintained through Indian Red Cross Society (IRCS) under PPP mode. The Janani Shishu Suraksha Karyakram funds are released

to IRCS directly by Tamil Nadu Health System Project for fleet management and operation. The Project Director Tamil Nadu Health System Project has offered to take up the maintenance of 32 Mobile Therapy Units exclusively allotted for the welfare of the 0-6 age group of differently abled children, under this scheme.

- 4. The State Commissioner for the Differently Abled has requested the Government to examine and accord necessary approval for attaching the 32 Mobile Therapy Units with IRCS for the limited purpose of maintenance of the fleet. In other words, the 32 Mobile Therapy Units will be operating under this department and these will be under the direct control of the Collectors of the respective districts.
- 5. The Government, after careful examination of the proposal of the State Commissioner for the Differently Abled, issue the following orders:-
 - Under Janani Shishu Suraksha Karyakram Scheme, the Project Director, Tamil Nadu Health System Project is permitted to maintain the 32 Mobile Therapy Unit (Vans) by attaching with Indian Red Cross Society (IRCS) for the limited purpose of maintenance of the fleet and operations. These 32 Mobile Therapy Units will be operating under this department and they will under the direct control of the Collectors of the respective districts.
 - ii. These 32 vehicles will be exclusively used for differently abled children in 0-6 age group and their mothers.
- 6. This order issues with the concurrence of the Finance Department vide its U.O.No.58297/Fin(SW)/2016, dated 09.12.2016.
