The Project would be implemented in 3 Phases, beginning from January 2005 with the support of the World Bank. The 18 Phase of the Project would be for a period of 18 months. The 2 Phase would also be for a period of 18 months and the last Phase of the Project would cover the remaining 2 years. Administrative sanction was accorded for the Project in the Government Order 1st read above. A Project Management Unit at the State level has been established for the Project under the supervision of a Project Director, sanctioned in the cadre of an I.A.S. in the Government order 2<sup>nd</sup> read above. The Project Management Unit has become functional from 1-4.2005.

- 2. The Project Director has requested the Government to designate the Project Director, Tamil Nadu Health Systems Project, as a Head of the Department under the administrative control of the Health and Family Welfare Department.
- 3. The Empowered Committee constituted for the Tamil Nadu Health Systems Project has suggested in the meeting held on 9.6.2005, that Government Order designating the Project Director, Tamil Nadu Health Systems Project, as Head of department in the department of Health and Family Welfare may be issued by the Department itself.

4. Considering the importance and magnitude of the time bound Tamil Nadu Health Systems Project, the Government have decided that the Project Director should be declared as Head of the Department exclusively for implementing the Project. Accordingly, the Government declare the Project Director, Tamil Nadu Health Systems Project, as Head of Department for purpose of the Fundamental Rules. The Project Director shall exercise all financial and administrative powers vested with a Head of Department.



Order:

There are 11000 Medical Officers working in the Department of Health and Family Welfare. These Medical Officers were appointed through various modes of appointment. Some Medical Officers are selected by the Tamil Nadu Public Services Commission, some are under temporary appointment and some are under contract appointment. These Medical Officers are in various categories, namely, General Duty Medical Officers, Specialists, Tutors, Assistant Professors, Professors, Readers, etc. Some Medical Officers are occupying administrative posts. The Medical Officers are working under three directorates, namely, the Directorate of Medical and Rural Health Services, Directorate of Public Health and Preventive Medicine and Directorate of Medical Education. They keep moving from one directorate to another and their movement is not always unidirectional. More over, about 12 % of the doctors in service undergo Postgraduate courses at any given point of time, since 50% of the Post Graduate seats are reserved for service candidates. It is not always possible to locate the whereabouts of some Medical Officers since these Medical Officers go on leave or are on unauthorised absence. Due to these reasons, it is found that several posts of Medical Officer are vacant in many important places like Comprehensive Emergency Obstetric and Newborn Care (CEmONC) Centres, Referral Hospitals, Primary Health Centres, etc. Absence of Medical Officers hampers the proper delivery of health care services to the poor. It is, therefore, important to create and maintain a Data Bank for all the Medical Officers for better monitoring and delivery of 2. The Tamil Nadu Health Systems Project (TNHSP) has planned to take up Health Management Information System (HMIS) for better monitoring of health services. Creation of a database for all the doctors working in the Department of Health and Family Welfare is an integral part of Health Management Information System. Under the Project, it is proposed to develop a Web based Data Bank for Medical Officers. This Data Bank will include details of all medical officers coming under Tamil Nadu Medical Services whether they are regular, temporary, on contract, undergoing Post Graduate training or on leave. It will be easier to take administrative decisions once the Data Bank is created and regularly updated. The data that needs to be updated will be collected from the districts as follows:



Creation of a Personnel Data Bank is an approved activity in the Project Implementation Plan (PIP) of the Tamil Nadu Health Systems Project.

3. The Project Director, Tamil Nadu Health Systems Project, has proposed to hire the services of a Software Company, with previous experience in creating the database and hand holding for one year. Maintenance of the database and the software will be carried out by a professional company from the second year onwards. The Consultant Firm will be hired by the Project Director, Tamil Nadu Health Systems Project, by following the World Bank Procurement procedures. The non-recurring cost involved in the proposal is Rs. 2.80 lakh. The recurring cost towards maintenance of the database and software is

- Rs 1.20 lakh per annum from the second year onwards. The above mentioned cost is eligible for reimbursement by the World Bank.
- 4. The Project Director, Tamil Nadu Health Systems Project, has placed the above proposal before the State Empowered Committee for approval. The State Empowered Committee has approved the proposal. The Project Director, Tamil Nadu Health Systems Project, has now requested the orders of the Government.
- The Government, after careful examination of the proposal, issues the following orders.
- i. Sanction is accorded for a nonrecurring expenditure of Rs. 2.80 lakh (Rupees Two lakh and eighty thousand only) for creation of a Web based Data Bank for Medical Officers in the Tamil Nadu Medical Services as follows.

ii. Sanction is accorded for a recurring expenditure of Rs. 1.20 lakh (Rupees One lakh and twenty thousand only) from the second year onwards towards maintenance of the database and software by hiring the services of a Software Consultant firm as follows.

- iii. The Project Director, Tamil Nadu Health Systems Project, is permitted to execute the task of creation of a Web based Data Bank for Medical Officers in the Tamil Nadu Medical Services and maintenance of the same by hiring the services of a Software Consultant firm.
- iv. The Project Director, Tamil Nadu Health Systems Project, is permitted to hire the services of a Software Consultant firm at a cost not exceeding Rs 2.80 lakh and maintenance of the same from the second year onwards at a cost not exceeding Rs.1.20 lakh by following the World Bank procurement procedures and to pay the Consultant Firm.

- 6. The non recurring expenditure of Rs. 2.80 lakh towards hiring a Consultant firm to create a Web based Data Bank for Medical Officers and recurring expenditure of Rs. 1.20 lakh per annum towards maintenance of the same shall be debited to the the head of account "2210. Medical and Public Health 80. General 004. Health Statistics and Evaluation Schemes in the Tenth Five Year Plan II. State Plan PA. Building Capacity to strengthen the Health Management Information System 33. Payments for Professional and Special Services 03. Special Services (DPC 2210 80 004 PA 3331).
- 7. The Project Director, Tamil Nadu Health Systems Project, is permitted to incur a nonrecurring expenditure of Rs 2.80 lakh towards hiring a Consultant firm to create a Web based Data Bank, over and above the budget provision, pending provision of funds in Revised Estimate / Final Modified Appropriation 2005-06. Necessary funds will be provided in Revised Estimate / Final Modified Appropriation 2005-06 and the Project Director shall send necessary proposals to the Government in Finance department for including the expenditure in Revised Estimate / Final Modified Appropriation 2005-06 at the appropriate time.
- 8. This order issues with the concurrence of the State Empowered Committee constituted in G.O. Ms. No. 28, Health and Family Welfare, dated 28.2.2005 and the concurrence of Finance Department vide its U.O. No. 71 / DS (PU) / 2005, dated: 13.12.2005 and Additional Sanction Ledger No. 1208.

#### Order:

In the Government Order 1st read above, sanction was accorded for a sum of Rs 14.70 lakh as non recurring expenditure towards procurement of lab equipments, conversion of vans into outreach vans, Grant for creating public awareness and advertisement charges and Rs 72.72 lakh per annum as recurring expenditure towards Grants for Insurance, Fitness Certificate, Fuel and maintenance of outreach vans, support for salary and drugs, etc, for establishment of 12 mobile outreach services in 12 tribal concentrated areas in 10 districts in the State during the project period of the Tamil Nadu Health Systems Project. The Project Director, Tamil Nadu Health Systems Project, was permitted to modify 12 Eicher Vans into Outreach Vans through the State Health Transport Organisation (SHTO) at a total cost of Rs 9.00 lakh.

- 2. The Project Director, Tamil Nadu Health Systems Project, has now stated that the matter was discussed with the World Bank and the World Bank has not accepted the procedure of involving the State Health Transport Organisation, as the Project Appraisal Document envisaged that the Tamil Nadu Medical Services Corporation (TNMSC) is the only agency for procurement of goods for this project. The Project Director has further stated that the salary of Driver has been indicated as Rs 5000/- per month, which is higher than the salary of the staff nurse. Therefore, the Project Director has suggested that the salary of the Driver should be revised and has proposed to issue amendments to the Government Order 1st read above, permitting the Project Director, Tamil Nadu Health Systems Project, to modify the 12 Eicher Vans into Outreach Vans through the Tamil Nadu Medical Services Corporation instead of the State Health Transport Organisation and to reduce the salary of the Driver from Rs. 5000/- per month to Rs. 3000/- per month.
- 3. The Project Director, Tamil Nadu Health Systems Project, has placed the above proposal before the State Empowered Committee of the Tamil Nadu Health Systems Project and has obtained its approval. She has requested to issue suitable amendments to the Government order 1st read above.

4. Based on the approval of the State Empowered Committee, the Government issues the following amendments to the Government order 1<sup>st</sup> read above.

### <u>Amendments</u>

- i. For the words "one driver @ Rs. 5000/- per month" occurring under Column 2 against Serial number A (3) in the Table in para 6 (ii) of G.O 2D. No. 47, Health & Family Welfare, dated: 21.07.2005, the words "one driver @ Rs. 3000/- per month" shall be substituted.
- ii. For the existing para 6 (iii) of the Government Order, the following para shall be substituted.

"The Project Director, Tamil Nadu Health Systems Project, is permitted to procure the laboratory equipments and modify the 12 Eicher Vans into Outreach Vans through the Tamil Nadu Medical Services Corporation. The Project Director, Tamil Nadu Health Systems Project, is authorised to draw and release the amount of Rs 12.00 lakh, sanctioned for laboratory equipments, conversion of vehicle into outreach vans and advertisement charges, in advance, to the Personal Deposit account "K. Deposit and Advances (b) - Deposits not bearing Interest - 8443.00. Civil Deposits - 800. Other Deposits - CE. Deposits of Tamil Nadu Medical Services Corporation (D.P. Code: 8443.00 - 800. CE - 000H (Receipts))" of the Managing Director, Tamil Nadu Medical Services Corporation, for the same"

iii. For the existing para 6 (iv) of the Government Order, the following para shall be substituted.

"The Managing Director, Tamil Nadu Medical Services Corporation, is permitted to incur the expenditure and procure the laboratory equipments for the 12 Outreach Vans as per the detailed specifications furnished by the Project Director, Tamil Nadu Health Systems Project and convert the 12 Eicher vans supplied by the Director, State Health Transport Organisation, into Outreach Vans fitted with the above equipments by following the World Bank procurement procedures and deliver the fully furnished Outreach Vans to the concerned Joint Directors of Medical, Rural Health Services and Family Welfare. The Managing Director, Tamil Nadu Medical Services Corporation, is directed to settle the accounts with the Project Director, Tamil Nadu Health Systems Project."

iv. For the existing para 6 (v) of the Government Order, the following para shall be substituted.

"The Project Director, Tamil Nadu Health Systems Project, is permitted to modify the 12 Eicher Vans into Outreach Vans through the Tamil Nadu Medical Services Corporation. The provision of Rs. 66.00 lakh earmarked for purchase of motor vehicles in Budget Estimate 2005-2006 under the head of account "2210. Medical and Public Health – 06. Public Health – 796. Tribal Areas Sub Plan – Schemes in the Tenth Five Year Plan – II. State Plan - PB. Procurement through Tamil Nadu Medical Services Corporation for Tribal Health under Health Systems Project - 21. Motor Vehicles - 01. Purchase (DPC: 2210 06 796 PB 2119)" may be re-appropriated to "21. Motor Vehicles — 02. Maintenance of Functional Vehicles (DPC: 2210 06 796 PB 2121)" of the above head of account".

v. For the existing para 6 (vi) of the Government Order, the following para shall be substituted.

"The Director, State Health Transport Organisation, is directed to handover the 12 Eicher Vans to the Managing Director, Tamil Nadu Medical Services Corporation, for conversion into Outreach Vans".

vi. For the existing para 7 (ii) of the Government Order, the following para shall be substituted.

"The nonrecurring expenditure of Rs 9.00 lakh towards conversion of the Eicher Vans into Outreach Vans shall be debited to the head of account "2210. Medical and Public Health - 06. Public Health - 796. Tribal Areas Sub Plan - Schemes in the Tenth Five Year Plan - II. State Plan - PB. #### Order:

The Government of Tamil Nadu is taking a number of initiatives to bring down Infant Mortality Rate (IMR) and Maternal Mortality Ratio (MMR) and one of the initiatives taken by the Government is provision of 24 hours Comprehensive Emergency Obstetric and Newborn Care Services (CEmONC) to the people. The Government, in the Government Order 1<sup>st</sup> read above, issued orders for establishment of 62 CEmONC Centres in 62 hospitals throughout the State, at the rate of at least 2 hospitals in a District with the following staff structure in order to provide quality emergency obstetric and neonatal care services uninterruptedly.

i. Obstetrician and Gynaecologists	-	4
ii. General Surgeons	-	2
iii. Paediatric Physicians	10-10-11	4
iv. Anaesthetists	-	2
v. Staff Nurses	-	32

Out of these 62 Centres, 11 Centres are in Medical College hospitals and 51 Centres are in district and sub district hospitals. Due to insufficient sanctioned posts of Staff and want of equipments in many of the 51 CEmONC Centres in the district and sub district hospitals, they are not able to provide 24 hours CEmONC services to the Public.

2. The Tamil Nadu Health Systems Project is under implementation in the State with the support of the World Bank at an estimated cost of Rs. 597.15 crore for a period of 5 years. One of the objectives of the Project is to significantly improve the effectiveness of the Health System through increased access and utilisation of health services, particularly by the poor, disadvantaged and tribal groups. The Project also aims to reduce maternal and neonatal mortality in Tamil Nadu. Under the Tamil Nadu Health Systems Project, the CEmONC hospitals

would be equipped with trained staff, special equipments, drugs and supplies etc. Special protocols would be developed to standardise the treatment. In order to provide quality emergency obstetric and neonatal care services continuously in all the CEmONC hospitals, the Project Director, Tamil Nadu Health Systems Project, has placed proposals for appointment of Specialist Medical Consultants and Nurses on contract basis for providing 24 hours CEmONC services and provision of equipments and goods to the CEmONC hospitals and training in Ultra Sonography to Obstetrics and Gynaecology Specialists in the CEmONC hospitals for their skill upgradation and maintenance of equipments. The proposals are included in the Project Implementation Plan (PIP), which have been approved by the World Bank. The nonrecurring expenditure and recurring expenditure involved in the proposal is Rs 1309.96 lakh and Rs. 353.20 lakh respectively. The above expenditure is eligible for reimbursement by the World Bank.

- 3. The State Empowered Committee has approved the proposal of the Project Director, Tamil Nadu Health Systems Project. Based on the approval of the State Empowered Committee, the following orders are issued.
- i. Sanction is accorded for appointing 200 Specialist Medical Consultants in the categories of Obstetrician and Gynaecologists, General Surgeons, Paediatric Surgeons and Anaesthetists, on contract basis to work in the CEmONC hospitals, indicated in Annexure I to this order, for the Project period of 5 years and to incur a recurring cost of Rs 240.00 lakh (Rupees Two hundred and forty lakh only) per annum, totalling Rs. 1200.00 lakh for a period of 5 years towards their contract payment. The recruited Specialist Medical Consultants shall be paid a consolidated pay of Rs. 10,000/- per month for Post Graduate degree holders and Rs. 9,000/- per month for Post Graduate Diploma holders in the concerned Speciality.
- ii. The Project Director, Tamil Nadu Health Systems Project, is permitted to recruit the required number of Contract Specialist Medical Consultants in the categories of Obstetrician and Gynaecologists, General Surgeons, Paediatric Surgeons and Anaesthetists, as per the requirement furnished by the Director of Medical and Rural Health Services, within the overall total number of 200 Medical Consultants, through the District level Selection Committee headed by the District Collector, by calling for a list from the Professional Employment Exchange. The selection shall be made based on the Employment Exchange seniority and by observing communal rotation. The Medical Officers will be recruited for particular hospitals in the districts where the vacancies exist.
- iii. Sanction is accorded for appointing 200 Nurses on contract basis to work in the CEmONC hospitals for the Project period of 5 years and to incur a recurring cost of Rs 60.00 lakh (Rupees Sixty lakh only) per annum, totalling Rs. 300.00 lakh for a period of 5 years towards their contract payment. The recruited Nurses shall be paid a consolidated pay of Rs. 2,500/- per month.
- iv. The Director of Medical and Rural Health Services shall recruit the Nurses from the seniority list (maintained in the Directorate) of qualified Nurses waiting for appointment, by observing seniority and communal rotation. The Director of Medical and Rural Health Services shall issue posting to the Nurses to work in the CEmONC hospitals exclusively for CEmONC services.

- v. The Director of Medical and Rural Health Services is directed not to transfer the Medical Consultants and Nurses from the CEmONC hospitals to which they are posted. When circumstances demand such transfers, he is directed to transfer them to other CEmONC hospitals only after obtaining the orders of the Government under recommendation by the Project Director, Tamil Nadu Health Systems Project.
- vi. The Project Director, Tamil Nadu Health Systems Project, is authorised to allocate sufficient budget to the Joint Directors of Medical, Rural Health and Family Welfare of the concerned districts where the Medical Consultants and Nurses are posted for making the contract payment.
- vii. The Joint Directors of Medical, Rural Health and Family Welfare of the concerned districts are directed to send a monthly consolidated expenditure statement, towards the contract payment of the Medical Officers, to the Tamil Nadu Health Systems Project.
- viii. Sanction is accorded for a non-recurring expenditure of Rs. 1,250.00 lakh (Rupees One thousand two hundred and fifty lakh only) towards purchase of equipments and goods, indicated in the Annexure II to this order, to the 51 CEmONC hospitals.
- ix. Sanction is accorded for a nonrecurring expenditure of Rs. 19.96 lakh (Rupees Nineteen lakh and ninety six thousand only) towards organising 15 days training in Ultra Sonography to 204 Obstetrics and Gynaecology Specialists in the CEmONC hospitals. Sanction is also accorded for a nonrecurring expenditure of Rs. 40.00 lakh (Rupees Forty lakh only) towards purchase of training equipments viz, 2 Ultra Sonogram machines with teaching attachments and 2 Computers as indicated in the Annexure III to this order.
- x. The Project Director, Tamil Nadu Health Systems Project, is permitted to procure the equipments and goods indicated in the Annexure II and III through the Tamil Nadu Medical Services Corporation. The Project Director, Tamil Nadu Health Systems Project, is also authorised to draw the amount of Rs 1290 lakh sanctioned in paras viii and ix above in advance and release the same to the Personal Deposit account "K. Deposit and Advances (b) Deposits not bearing interest 8443.00. Civil Deposits 800. Other deposits CE. Deposits of Tamil Nadu Medical Services Corporation (D.P. Code: 8443.00 800 CE 000H (Receipts)" of the Managing Director, Tamil Nadu Medical Services Corporation, towards procurement and supply of the equipments and goods.
- xi. The Managing Director, Tamil Nadu Medical Services Corporation, is permitted to incur the expenditure and procure the equipments and goods, indicated in the Annexure II and III to this order, as per the detailed specifications furnished by the Project Director, Tamil Nadu Health Systems Project, by following the World Bank procurement procedures and supply the same to the Superintendents / Chief Medical Officers of the CEmONC Hospitals (indicated in the Annexure I to this order) / Training Institute. The Managing Director, Tamil Nadu Medical Services Corporation, is directed to settle the accounts with the Project Director, Tamil Nadu Health Systems Project.

The Secondary Care Hospitals comprising of 29 district headquarters hospitals and 241 sub district hospitals play a vital role in providing maternal and childcare services to the people in Tamil Nadu. About 30 % of 11.5 lakh deliveries occurring in the State every year are conducted in the secondary care hospitals. Lakhs of antenatal mothers come to these hospitals for antenatal check up, treatment and delivery. Ultra Sonogram is a useful diagnostic tool to find out the abnormalities in pregnancy, foetal anomalies and to monitor the progress of the growth of the foetus.

- 2. The Project Director, Tamil Nadu Health Systems Project, has stated that during 1996, 189 Ultra Sonograms were provided to these hospitals under the India Population Project V (IPP-V) supported by the World Bank. Out of the 189 Ultra Sonograms, 91 Ultra Sonograms are out of order and they have to be condemned as they are beyond repair. In order to provide continued quality antenatal care services in the Government Hospitals and to bring down the maternal mortality and morbidity, the Project Director has proposed to replace the non functioning Ultra Sonograms in 79 secondary care hospitals. The remaining 12 secondary care hospitals have been designated as CEmONC hospitals and they would be provided with Ultra Sonograms separately. She has also proposed to impart skill development training to 158 Medical Officers i.e, 2 Medical Officers from each of the 79 hospitals, who are going to operate the Ultra Sonogram machines in these hospitals, in batches, at the Government Kasturba Gandhi Hospital and Institute of Obstetrics and Gynaecology, Chennai. This activity is included in the Project Implementation Plan document (PIP) approved by the World Bank. The cost towards equipment maintenance is eligible for reimbursement by the World Bank.

Studies have indicated that the tribal population in Tamil Nadu have considerably worse health outcomes than the non-tribal population and they have substantially lower utilisation of health services. Health problems of tribal populations across the State are not uniform. Despite a number of interventions by the State Government, the vulnerable tribal community is still unable to access basic health care. They continue to face a number of social, cultural, legal, economic and political constraints. The Tamil Nadu Health Systems Project has developed a number of interventions to increase health service utilisation and thus improve the health outcomes of the tribal population in Tamil Nadu.

- 2. In order to assist the Government to rationally allocate additional resources and address inequalities in health status across tribal subpopulations as well as improving access to health services and improving the health status of the tribal population, the Project Director, Tamil Nadu Health Systems Project, has proposed to hire a Consultant Firm to conduct a baseline study that will assess health care utilisation and develop a morbidity profile among the tribal population within the State. The World Bank supported Tamli Nadu Health Systems Project (TNHSP), among other things, aims to strengthen the infra structure facilities of 270 Secondary level hospitals in the State in a phased manner. The interventions include additions and extensions to the existing hospital buildings, provision of additional buildings, renovation and repair of the existing hospital buildings, provision of hospital equipments, furniture, hospital supplies, office equipments, vehicles, etc.

- 2. The Project Director, Tamil Nadu Health Systems Project, has stated that it has been planned to undertake many innovative activities to improve the health status of the people of Tamil Nadu, especially, the poor and disadvantaged. For this purpose, the services of Consultants and Specialists need to be procured. The duration of the project is for five years i.e, from January 2005 to March 2010. The implementation and the outcome of the Project will be assessed periodically by the World Bank, through agreed monitoring indicators. Since project is time bound and the activity time frame has to be adhered to, it is essential that the procurement of the civil works, equipments and services need to be expedited. Moreover, the World Bank procurement procedures need to be followed to procure the above, in order to become eligible for reimbursement by the World Bank. Hence, the Project Director, Tamil Nadu Health Systems Project, has placed a proposal before the State Empowered Committee for approval of the procurement procedure under the Tamil Nadu Health Systems Project throughout the Project period.
- 3. The State Empowered Committee, in its meeting held on 9.6.2005, has approved the proposal of the Project Director, Tamil Nadu Health Systems Project, with certain modifications. Based on the approval of the State Empowered Committee, the Government issues the following orders:

(i). The Project Director, Tamil Nadu Health Systems Project, is permitted to procure the Civil Works under the Tamil Nadu Health Systems Project as per the procedure detailed below.

"The Civil Works shall be carried out in all the hospitals in the districts in the State in a phased manner. The Civil works would involve renovations, extensions and additional buildings for the 270 hospitals. Works related to Health Care Waste Management Programme shall also be taken up in these hospitals. In addition, construction of an Annexe building for the Directorate of Medical and Rural Health Services shall be taken up to house the Project Management Unit (PMU) of the Project. Civil works shall be carried out by the Public Works Department, as per their existing procedure, by following the plan given below:

- a. The Project Management Unit would identify the civil works to be undertaken.
- b. The Project Director shall intimate to the Chief Engineer (Buildings), Public Works Department, about the place and nature of the work to be carried out.
- c. The drawings for the civil works, as communicated by the Project Director, shall be prepared by the Architect Wing of the Public Works Department / by hiring the services of Private Architects by the Project Management Unit.
- d. The drawings on approval by the World Bank Consultant Architect shall be communicated to the Public Works Department for preparation of bidding documents, which shall be vetted by the Chief Engineer (Buildings), Public Works Department. The Project Director, Tamil Nadu Health Systems Project, shall get it approved by the World Bank Procurement Consultant, as the case may be.
- e. The Public Works Department shall advertise for invitation for bids (IFB), process the tenders and award works duly observing the World Bank procurement procedures.
- f. The Chief Engineer (Buildings), Public Works Department shall intimate the Department of Finance about the nature and cost of work and the executing officers, for issue of Letter of Credit (LOC).
- g. The Department of Finance shall issue Letter of Credit as per the existing rules with a copy to the Project Director, Tamil Nadu Health Systems Project.
- h. The Engineering Cell in the Project Management Unit shall periodically monitor the progress of work and receive the periodical statements from the Executive Engineers concerned.
- i. When the contractor submits the claim bill for payment, the Executive Engineer of the concerned district shall prepare the pass order and make the payment to the contractor as per rules.
- j. The Executive Engineer of the district units shall send monthly Statements indicating the physical and financial progress in the prescribed format to the Project Director, Te mil Nadu Health Systems Project.
- k. The Chief Engineer (Buildings), Public Works Department, shall send a consolidated

progress report to the Project Director, Tamil Nadu Health Systems Project, once a month.

ii. The Project Director, Tamil Nadu Health Systems Project, is also permitted to procure the equipments, goods, vehicles, etc, under the Tamil Nadu Health Systems Project, through the Tamil Nadu Medical Services Corporation as per the procedure given below.

"Hospital equipments, office and hospital furniture, office equipments, hospital supplies, medicines, vehicles and other equipments shall be procured under this category. At present, the Tamil Nadu Medical Services Corporation (TNMSC) is procuring medicines and equipments for the Health and Family Welfare Department. The procurement of the above category of equipments, goods, vehicles, etc, required for the Tamil Nadu Health Systems Project shall also be procured through the Tamil Nadu Medical Services Corporation by following the World Bank Procurement Procedures. The existing system of Tender Scrutinising Committee and Tender Finalisation Committee for the Tamil Nadu Medical Services Corporation shall be retained for procurement for the Tamil Nadu Health Systems Project also. The Project Director, Tamil Nadu Health Systems Project, shall release quarterly advance payments to the Personal Deposit account of the Tamil Nadu Medical Services Corporation and the Managing Director, Tamil Nadu Medical Services Corporation, shall make the payment to the firms supplying the equipments.

iii. The District Project Management Units are permitted to procure hospital supplies under the Tamil Nadu Health Systems Project for day-to-day Office use, within the financial powers of Joint Director of Medical, Rural Health Services and Family Welfare. They shall purchase some of the hospital supplies like reagents, detergents, stationery, etc in small quantities within the financial powers of the Joint Director of Medical, Rural Health Services and Family Welfare to carry out routine day to day activities in the institutions under their jurisdiction as well as for their office use.

iv. The Project Director, Tamil Nadu Health Systems Project, is permitted to procure the services under this Project as per the procedure given below

"The services to be procured under the Tamil Nadu Health Systems Project shall include Consultant services to carry out Studies and Surveys, conducting training, contracting technical and non technical staff for the Project Management Unit / District Project Management Units and for health institutions. The procurement of the services planned for a wide range of activities shall include hiring of professionals on contractual basis for the above units as well as for conducting Training, Workshops, contracting Non Governmental Organisations, Information, Education and Communication (IEC) Studies, Evaluation and other Consultancy Services. The Project Director, Tamil Nadu Health Systems Project, shall procure the above services by following the World Bank Procurement procedures. Approval of the Tender Scrutinising and Tender Finalising Committees, constituted in the Government Order 1st read above, shall be obtained.

The Project Director, Tamil Nadu Health Systems Project, shall affocate budget provision, wherever necessary, to the Joint Director of Medical, Rural Health Services and Family Welfare concerned for the services to be procured by the District Project Management Unit, who shall in turn present the bills for payment in the Treasury and make the payments to the concerned Consultants".

- v. The Project Director, Tamil Nadu Health Systems Project, is authorised to constitute, wherever required, Technical Evaluation Committee consisting of experts (not exceeding 5 members) in the concerned fields to evaluate the technical bids.

Order:

Under the Tamil Nadu Health Systems Project, a Pilot Project has been planned for control of Non-Communicable Diseases (NCD) like Cardio Vascular diseases including hypertension. Pilot projects are being launched for control of Cancer Cervix in Theni and Thanjavur districts and for Cardio Vascular diseases in Villupuram and Theni districts. India contributes substantially to the global burden of Non-Communicable Diseases. In India, 12.5% of deaths are due to Coronary Artery Disease (CAD), 5% due to stroke, 3% due to Rheumatic Heart Disease (RHD) and 5% due to other cardio-vascular diseases (Totally 24% of deaths are attributed to cardiovascular diseases). Disability adjusted life years lost by Cardiovascular disease is 8%. This is likely to increase rapidly in the next decade and it may not be surprising to see 30-40% of deaths being attributed to cardiovascular diseases by the year 2010. The present high burden of deaths due to Non-Communicable Diseases is itself an adequate reason for public health attention. A greater cause for concern is the early age of these deaths in India compared to the developed countries. The prevalence of Coronary Heart Disease (CHD) is currently estimated to be around 10 % in urban adults aged 30 years and above (range: 8% - 12 %) and about 4% in rural adults aged 30 years and above (range: 3 - 5.5 %). During the period 2000- 2030, about 35% of all Cardio Vascular disease deaths in India will occur in the age group of 35 - 64 years. Moreover, the disease runs a virulent course leading to repeated hospitalisations and early deaths.

- 2. The high prevalence of Diabetes in urban and migrant Indians is also a cause for concern. Urban estimates of diabetes in adults aged over 35 years are in the range of 16-20%, while the corresponding rural estimates are around 4%. At present, India has the largest number of persons with diabetes in the world with an estimated 32.7 million in 2000. This is expected to nearly double by 2025, according to the projections by the World Health Organisation.
- 3. Cervical Cancer is one of the most common Cancer among women in India. About 1,00,000 new cases occur every year. Most of them seek medical help only at an advanced

stage. Early diagnosis of cancer cervix and prompt treatment can ensure an almost 100% cure rate. Incidence of cervical cancer is very high in Tamil Nadu. 80% of the population living in rural areas are at high risk due to low socio-economic status, poor genital hygiene, early marriage, multiparity etc. Incidence of cases of cancer cervix is 190,000 (Madras Cancer Registry, 2002). The primary target should be the women who are the "SILENT SUFFERERS"

- 4. Tamil Nadu has a very high incidence of road traffic accidents in India. A survey done by the Institute of Road Transport shows that Tamil Nadu stands second in number of road accident fatalities. The percentage of two wheelers in total vehicle population is very high. This unique feature results in a large number of serious injuries and fatalities in case of road accidents as the two-wheeler rider is extremely vulnerable even in case of small accidents. Apart from the fatalities occurring on the spot, many of the injured persons die because of delay in getting immediate trauma care. If proper medical care and immediate transportation to specialty hospitals is arranged, it is possible to reduce the number of fatalities and incidence of morbidity among the injured accident victims.
  - 5. The Specific interventions, therefore, could be at two levels:
    - (i) Primary Prevention, and
    - (ii) Secondary Prevention

#### Primary prevention

Preventing onset of disease by creating

- i. Awareness on risk factors leading to Non-Communicable Diseases, Coronary Vascular Disease and Diabetes. Some of the risk factors, which can help in prevention of these diseases are as follows:
  - a. Reduced tobacco and secondary smoke consumption,
    - b. Increased physical activity,
    - c. Increased consumption of healthy diet,
      - d. Reduced percentage of over weight people.
    - ii. Awareness about cervical cancer prevention and
    - iii. Awareness to reduce morbidity and mortality from traffic injuries.

### Secondary Prevention

Secondary prevention is with persons who have developed Cardio Vascular diseases or Diabetes. i.e. reducing the risk of complications after the onset of disease. Effective control of blood pressure, blood sugar, and foot care can prevent many complications and reduce death and disability. Cancer cervix is preventable and curable, if early screening and interventions are done. As far as road traffic accidents are concerned, the Tamil Nadu Health Systems Project has planned to strengthen the trauma care component and the emergency transportation of the injured.

- 6. The Project Director, Tamil Nadu Health Systems Project, has therefore, proposed the following activities by hiring the services of a Consultant Firm.
  - Develop communication materials to address Non Communicable Diseases prevention and control that can be implemented at the State, district and block levels;
  - Develop monitoring indicators in line with the planned materials and activities;
     and
  - Pre-test and finalise creative prototypes for the communication materials.

The communication materials at the community level will involve the use of behaviour change communication to increase knowledge of health issues addressed by the project, change attitudes and behaviour so that there is a reduced incidence of Non Communicable Diseases in the community and an increased utilisation of Non Communicable Diseases health services provided under the project in the pilot districts. This proposal has been included in the Project Implementation Plan (PIP) and Procurement Plan, which are approved by the World Bank. The nonrecurring cost involved in the proposal is Rs 16.40 lakh. The expenditure is eligible for reimbursement by the World Bank. It is also reflected in the Project Appraisal Document (PAD).

#### ORDER:

The World Bank supported Tamil Nadu Health Systems Project has become effective from 27.01.2005. The Government had agreed to establish a Strategic Planning Cell with full complement of staff within six months from the date of project effectiveness. A Project Management Unit (PMU) with 9 cells, including the Strategic Planning Cell, with supporting staff has been sanctioned in the Government Order 2<sup>nd</sup> read above. The following 4 Expert Advisers have been sanctioned to the Strategic Planning Cell to provide valuable inputs in all the surveys and evaluations to make them more effective and focused.

1. Expert Adviser in Hospital Reforms and Management

2. Expert Adviser in Human Resource and Health Management Information System

3. Expert Adviser in Health Systems Research and Health Economics

4. Expert Adviser in Partnership initiatives.

Out of the above 4 Expert Advisers, only 2 Expert Advisers, viz, Dr (Capt) M. Kamatchi and Dr. Nevin Wilson are rendering their services as Expert Advisers in Hospital Reforms and Management and Partnership Initiatives respectively. The qualifications, responsibilities and remuneration for all the 4 expert advisors have been approved in the Government Order 3<sup>rd</sup> read above.

- 2. The Project Director, Tamil Nadu Health Systems Project, has stated that many activities of the Project, including Health Management Information System and Human Resource Development, especially, the training of Health Care Providers, have to be taken up immediately. Hence, there is an urgent need to fill up the post of Expert Adviser for Human Resource and Health Management Information System. The Project Director has stated that Dr. V. Suthanthira Vanitha, MBBS, DGO, retired Additional Director of Medical and Rural Health Services, has been associated with the Project planning activities since 2003 and project implementation since the project became effective in January 2005. She has all the necessary qualifications required for the above post. She has been collecting "Institutional Services Monitoring Reports" (ISMR) from all the secondary care hospitals in the State for the last two years and has been analysing the report and sending the feed back.
