ORDER:-

The Hon'ble Minister for Health and Family Welfare has made the following announcement (Announcement No.28) on the floor of the Tamil Nadu Legislative Assembly while moving the Demand No.19 of the Health and Family Welfare Department on 18.04.2023: -

"கோயம்புத்தூர் அரசு மருத்துவக் கல்லூரி மருத்துவமனையில் நீராவி சலவை (Steam Laundry) வசதி ரூ.2.45 கோடி மதிப்பீட்டில் ஏற்படுத்தப்படும்".

2. In the letter read above, the Project Director, Tamil Nadu Health System Reform Program has stated that Coimbatore Medical College Hospital is functioning with More No. of Operation Theatre and the linen generation including ICU, OICU, ICCU, IMCU, Toxicology ICU, TAEI ward — Red Zone, Yellow zone, Red zone and Non other ward ICU will be around 1000 pieces per day and the present laundry system is not capable to wash such quantity daily, due to its low capacity. The Existing machines efficiency is very low and it is more than 30 years old. They break down frequently due to wear and tear and very long usage and huge amount was incurred for its repairs at every time. It affects the routine work of the hospital and necessary to replace with new machines to cater the present load. And it will also prevent the infection rate among the patients and reduce the hospital delays, thereby it reduces running cost of the hospital.

3. The Project Director, Tamil Nadu Health System Reform Program has sent a proposal towards the provision of Steam Laundry with Infrastructure to the Government Medical College Hospital, Coimbatore along with the following budget estimation: -

4. The Project Director, Tamil Nadu Health System Reform Program has stated that the above proposal was approved by the State Empowered Committee and hence, he has requested to issue necessary orders in this regard.

5. Further, the Project Director, Tamil Nadu Health System Reform Program has stated that the Engineer in Chief, Public Works Department has informed that out of the amount of Rs.2,43,15,285/- a sum of Rs.75,00,000/- is required for this year 2023-2024 and the remaining amount of Rs.1,70,00,000/- for next Financial year 2024-2025.

6. The Government, after careful examination, have decided to accept the proposal of the Project Director, Tamil Nadu Health System Reform Program and accordingly issue the following orders:-

- i. Administrative sanction is accorded for a sum of Rs.2,18,84,285/- (Rupees Two crore eighteen lakh eighty four thousand two hundred and eighty five only) towards execution of civil and electrical works for the Steam Laundry in Government Medical College Hospital, Coimbatore through Public Works Department.
- ii. Administrative sanction is accorded for a sum of Rs.24,31,000/- (Rupees Twenty-Four Lakh thirty-one thousand only) towards procurement of equipment for the Steam Laundry for Government Medical College Hospital, Coimbatore, through Tamilnadu Medical Service Corporation Limited.
- iii. The Director of Medical Education and Research is authorized to draw and disburse the expenditure sanctioned in paragraph 6 (i) above and follow the conditions stipulated in the Tamil Nadu Health System Reform Program (TNHSRP) guidelines.
- iv. The Director of Medical Education and Research is authorized to draw the amount sanctioned at para 6(ii) above and deposit the same in to the Personal Deposit account of the Managing Director, Tamil Nadu Medical Services Corporation Limited so as to procure the equipment and supply.
- v. The Director of Medical Education and Research is directed to maintain a separate account exclusively for Tamil Nadu Health System Reform Program funds in Directorate, which should be operated by joint signatory.

7. The expenditure sanctioned in paragraph 6(i) above shall be debited under the following Head of account: -

"4210 — Capital Outlay on Medical and Public Health -01 Urban Health Services – 200 Other Health Schemes – Externally Aided Project – PC, Tamil Nadu Health Systems Reforms Project – 416 – Major Works -01 – Major Works."

(IFHRMS DPC 4210 01 200 – PC – 41601)

8. Necessary funds of Rs.75,00,000/- will be provided in Revised Estimate/ Final Modified Appropriation 2023 – 2024. Pending provision of such funds, the Director of Medical Education and Research is authorized to draw and disburse the above sanctioned amount in para 6(i) above. However, this expenditure shall be brought to the notice of the Legislature by Specific Inclusion in the Supplementary Estimates

2023-2024. The Director of Medical Education and Research is also requested to include this expenditure while sending the budget proposals for Revised Estimate / Final Modified Appropriation 2023 - 2024 and also send draft explanatory notes for inclusion of this expenditure in the Supplementary Estimates 2023-2024 to Government in Finance (BG-I/Health-II) Department at an appropriate time without fail.

9. This order issues with the concurrence of Finance Department vide e-File No.3275/2023, dated 08.01.2024 and ASL No.1678 (One thousand six hundred and seventy eight). (IFHRMS ASL No.2024011678).
