ORDER:

The Project Director, Tamil Nadu Health System Reform Program in the letter read above has stated that Tamil Nadu Health System Reform Program is supported by the World Bank aims at improving the quality of care in primary, secondary, and tertiary care facilities and proposed to take up the four Government Medical College Hospitals viz., Theni, Tiruvannamalai, Dharmapuri and Kanniyakumari are to be obtained Entry Level National Accreditation Board for Hospitals Accreditation in the year 2022-2023. She has furnished the National Accreditation Board for Hospitals Entry level Accreditation Standards and the estimated budget for Non-recurring cost to the activity as follows:-

2. The Project Director, Tamil Nadu Health System Reform Program has further stated that the State Empowered Committee had approved the above proposal and requested the Government to issue the necessary orders in this regard.

3. The Government after careful consideration of the proposal of the Project Director, Tamil Nadu Health System Reform Program have decided to accept the same and accordingly issue the following orders:-

- (i) Sanction is accorded for a non-recurring expenditure of Rs.13,84,00,000/- (Rupees Thirteen Crore Eighty four Lakh only) towards NABH entry level certification for the Government Medical College Hospitals in Theni, Tiruvannamalai, Dharmapuri and Kanniyakumari for gap closure activities.
- (ii) The Director of Medical Education is authorized to draw and disburse the above sanctioned amount.
- (iii) A separate account to be maintained exclusively for Tamil Nadu Health System Reform Program funds in the Directorate and the Medical College involved which should be operated by joint signatory.
- (iv) All expenditure from the allotted funds should be approved by the District Quality Committee.

4. The expenditure sanctioned in para 3 (i) above shall be debited to the following head of account:-
