In the circumstances reported by the Project Director, Tamil Nadu Health System Reform Program in the letter read above, the following amendment shall be issued to G.O. (Ms) No.425, Health and Family Welfare (EAPI-1) Department, dated: 22.10.2020.

### Amendment

(i) For the existing para 6 in the G.O.(Ms) No.425, Health and Family Welfare (EAPI-1) Department, dated: 22.10.2020, the para 6(f) shall be substituted as follows:-

“The Director of Medical Education is directed to select the candidate for the post of Emergency Department Secretary with Qualification of Diploma / B.Sc., (Nursing) through Contract mode by the Deans of the respective institution with the salary of Rs.14,000/- per month (as per NHM & MRB norms).”

(ii) For the existing annexure under the caption of “DETAILED BUDGET OF ALL ACTIVITIES” in the Government Order first read above, the salary for the post of Emergency Department Secretary read as Rs.14,000/- per month instead of Rs.20,000/- per month.
