#### ORDER:

The Project Director, Tamil Nadu Health System Reform Program in her letter read above has stated that the Tamil Nadu Health System Reform Program supported by the World Bank aims at improving the quality of care in primary, secondary, and tertiary care facilities to ensure healthy lives and promote well-being for all at all ages in line with SDG 3. The World Bank funds the program based on DLI (Disbursement Linked Indicators) in certain result areas. There are two disbursement-linked indicators which directly supports improved Quality of Care, of which DLI#2 focuses on the accreditation of public facilities. DLI #2 is a scalable indicator with an allocation of US\$38.2 million (INR 266.19 Crores). As per the DLI #2, 300 Primary Health Care facilities, 75 secondary health care and 4 Medical College hospitals (MCHs) should be certified by the end of the Project period. The achievements of DLIs are verified by a third-party IVA (Independent Verification Agency) using the agreed verification protocols.

- 5. After careful consideration of the proposal of the Project Director, Tamil Nadu Health System Reform Program, the Government have decided to accept the same and accordingly issue the following orders:
  - i. Sanction is accorded for a non-recurring expenditure of Rs.11,20,00,000/- towards accreditation of 160 primary health centers and urban primary health centers at the rate of Rs.7,00,000/- per Primary Health Center / Urban Primary Health Center as listed in Annexure-I.
  - ii. Sanction is accorded for a non-recurring expenditure of Rs.8,59,00,000/- towards accreditation of 21 Secondary health care facilities at the rate of Rs.50,000/- per bed as listed in Annexure–II.
  - iii. The Director of Public Health and Preventive Medicine is authorized to draw and disburse the amount sanctioned at para 5 (i) above.
  - iv. The Director of Medical and Rural Health Services is authorized to draw and disburse the amount sanctioned at para 5 (ii) above.
  - v A separate account to be maintained exclusively for Tamil Nadu Health System Reform Program funds in both Directorates and facilities involved which should be operated by Joint Signatory.
- 6. The expenditure is sanctioned in para 5(i) & (ii) above shall be debited to the following head of account respectively:-

2210 – Medical and Public Health – 01 Urban Health Services - Allopathy – 200 Other Health Schemes – Externally Aided Projects – PB – Tamil Nadu Health System Reform Project – Administrated by Director of Public Health – 309 Grants-in-Aid – 03 Grants for Specific Schemes.

The Director of Medical and Rural Health Services is also requested to include this expenditure while sending the budget proposals for RE/FMA 2022-2023 and also send necessary draft explanatory notes for inclusion of this expenditure in the Supplementary Estimates 2022-2023 to Government in Finance (Health-II/ BG-I) Department an appropriate time without fail.
