#### ORDER:

During the visit to Theni District on 30.04.2022, the Hon'ble Chief Minister has made the announcement as follows:-

"பெரியகுளம் அரசு மருத்துவமனை 8 கோடி ரூபாய் செலவிலும் உத்தமபாளையம் அரசு மருத்துவமனை 4 கோடி ரூபாய் செலவிலும் மேம்படுத்தப்படும்."

2. Based on the above announcement, the Project Director, Tamil Nadu Health System Reform Program in her letter read above, has sent a proposal to strengthening of Trauma and Emergency Care at Government Hospital, Uthamapalayam, Theni District at a cost of Rs.4,00,05,942/- and stated that the Tamil Nadu Health System Reform Program (TNHSRP) has been working towards improved provision of quality trauma care services. To Strengthen the Trauma and Emergency Care, the Government of Tamil Nadu has launched the Tamil Nadu Accident and Emergency Care Initiative (TAEI) Program in 2017 and 92 Government health facilities were designated as TAEI facilities. These TAEI centers are dealing with 6 pillars, namely Trauma, Myocardial Infarction, Stroke, Poison, Burns Paediatric Emergencies and other life-threatening conditions. As a front-line face lifting unit, these centres play a major role in quality management and bringing down the mortality. Further, the Gap analysis are being done regularly to identify new centres in the state to upgrade as a TAEI Centre with the provision of Infrastructures it has been identified etc.). Accordingly, Equipments, Government Hospital, Uthamapalayam, Theni District for Upgradation as TAEI Centre No.93 and furnished the vital statistics and general performance of the above said hospital.

3. The Project Director, Tamil Nadu Health System Reform Program has furnished the detailed plan for the Construction and the estimate of the non-recurring cost involved in this activity as furnished as follows:-

- 4. The Project Director, Tamil Nadu Health System Reform Program has stated that the proposal was approved by the State Empowered Committee and hence requested the Government to issue orders in this regard.
- 5. After careful consideration of the request of the Project Director, Tamil Nadu Health System Reform Program, the Government have decided to accept the same and issue the following orders:-
- Sanction is accorded for a sum of Rs.3,60,00,000/- (Rupees Three Crore and sixty lakh only) towards the Construction of Building in the Government Hospital, Uthamapalayam in Theni District through Public Works Department (PWD)
- ii) Sanction is accorded for a sum of Rs.40,05,942/-. (Rupees Forty Lakh Five Thousand Nine Hundred and Forty Two Only) towards the procurement of Equipment to the Government Hospital, Uthamapalayam, Theni District through the Tamil Nadu Medical Services Corporation Ltd.
- iii) The Director of Medical and Rural Health Services is authorized to draw and disburse the amount sanctioned at para 5(i) & (ii) above.
- iv) A separate account to be maintained exclusively for Tamil Nadu Health System Reform Program funds in Directorates and Facilities involved which should be operated by joint signatory.

- 6. The expenditure sanctioned in para 5(i) above shall be debited to the following head of account:-
  - 4210 Capital Outlay on Medical and Public Health-01 Urban Health Services 200 Other Health Schemes Externally Aided Projects PD Tamil Nadu Health Systems Reforms Project Administrated by the Director of Medical and Rural Health Services 416 Major Works 01 Major Works.

7. The expenditure sanctioned in para 5(ii) above shall be debited to the following head of account:-

- 8. Necessary additional funds of Rs.4,00,06,000/- will be provided in RE/FMA 2022-2023. Pending provision of such funds, the Director of Medical and Rural Health Services is authorized to draw and disburse the sanctioned amount in para 5(i) and (ii) above. However, this expenditure shall be brought to the notice of the legislature by Specific Inclusion to the Supplementary Estimates 2022-2023. The Director of Medical and Rural Health Services is also requested to include this expenditure while sending the budget proposals for RE/FMA 2022-2023 and also send draft explanatory notes for specific inclusion in the Supplementary Estimate 2022-2023 to Government in Finance (BG-I/Health-II) Department at an appropriate time without fail.
- 9. The Director of Medical and Rural Health Services is authorized to draw and deposit the sanctioned amount of para 5(ii) into the personal deposit account of Tamil Nadu Medical Services Corporation Limited, Chennai for the procurement of equipment through the Tamil Nadu Medical Services Corporation Limited, Chennai.
- 10. This order issues with the concurrence of the Finance Department vide its U.O.No.49893/Finance (Health-II)/2022, Dated:24.11.2022 and ASL No.1868 (One thousand eight hundred and sixty eight), (IFHRMS ASL No.2022111868).
