ORDER:

During the visit to Pudukottai District on 08.06.2022, the Hon'ble Chief Minister has made the announcement as follows:-

- "10 கோடி ரூபாய் செலவில் கூடுதல் படுக்கைகள், நவீன அறுவை சிகிச்சை அரங்கம் போன்ற வசதிகளோடு, திருமயம் வட்ட மருத்துவமனை தரம் உயர்த்தப்படும்."
- 2. Based on the above announcement, the Project Director, Tamil Nadu Health System Reform Program in her letter read above, has sent a proposal wherein it has been stated that the Tamil Nadu Health System Reform Program (TNHSRP) has been working towards improved provision of quality trauma care services. To Strengthen the Trauma and Emergency Care, the Government of Tamil Nadu has launched the Tamil Nadu Accident and Emergency Care Initiative (TAEI) Program in 2017 and 92 Government health facilities were designated as TAEI facilities. These TAEI centers are dealing with 6 pillars, namely Trauma, Myocardial Infarction, Stroke, Poison, Burns Paediatric Emergencies and other life-threatening conditions. As a front-line face lifting unit, these centres play a major role in quality management and bringing down the mortality. Further, the Gap analysis are being done regularly to identify new centres in the state to upgrade as a TAEI Centre with the provision of Infrastructures (Buildings, Equipments, etc.,). In line of the above, it has been identified the Government Hospital, Thirumayam,

Pudukottai District for Upgradation as TAEI Centre No.95 and furnished the vital statistics and general performance of the above said hospital. For Strengthening the Trauma and Emergency Care in that Government Hospital, it has to be strengthened to Level III TAEI center capacity and should be equipped with appropriate Infrastructure and Equipments and hence she has furnished the estimate of the non-recurring cost involved to establish the Comprehensive Emergency Care Centre works out to Rs.10.00 Crore and the detailed plan for the Construction as follows:

- 3. The Project Director, Tamil Nadu Health System Reform Program has stated that the proposal was approved by the State Empowered Committee and hence requested the Government to issue orders in this regard.
- 4. After careful consideration of the request of the Project Director, Tamil Nadu Health System Reform Program, the Government have decided to accept the same subject to the condition that no new human resources / posts shall be sought and existing man power to be utilized and issue the following orders:
 - i) Administrative sanction is accorded for a sum of Rs.10,00,00,000/- (Rupees Ten Crores only) towards the Establishment of Comprehensive Emergency Care Centre in the Government Hospital Thirumayam, Pudukottai District through Public Work Department (Medical Wing). Further, financial sanction is accorded for a sum of Rs.25,00,000/- (Rupees Twenty five lakhs only) for the financial year 2022-2023. The balance amount will be released in the subsequent financial years.
 - ii) The Director of Medical and Rural Health Services is authorized to draw and disburse the amount sanctioned above.
 - iii) A separate account to be maintained exclusively for Tamil Nadu Health System Reform Program funds in Directorates and facilities involved which should be operated by joint signatory.
- 5. The expenditure sanctioned in para 4(i) above shall be debited to the following head of account:-

4210 – Capital Outlay on Medical and Public Health-01 Urban Health Services – 200 Other Health Scheme - Externally Aided Projects – PD - Tamil Nadu Health Systems Reforms Project – Administrated by Director of Medical and Rural Health Services- 416 Major Works – 01 Major Works.

- 6. Necessary additional funds of Rs.25,00,000/- will be provided in RE/FMA 2022-2023. Pending provision of such funds, the Director of Medical and Rural Health Services is authorized to draw and disburse the amount sanctioned in para 4(i) above. However, this expenditure shall be brought to the notice of the legislature by Specific Inclusion in the Supplementary Estimates 2022-2023. The Director of Medical and Rural Health Services is also requested to include this expenditure while sending the budget proposals for RE/FMA 2022-2023 and also send draft explanatory notes for specific inclusion in the Supplementary Estimate 2022-2023 to Government in Finance (BG-I/Health-II) Department at an appropriate time without fail.
- 7. This order issues with the concurrence of the Finance Department vide its U.O.No.50757/Finance (Health-II)/2022, Dated:28.11.2022 and ASL No.1902 (One thousand nine hundred and two) (IFHRMS ASL No.2022111902).
