#### **ORDER:**

Initially the Director of Medical and Rural Health Services has sent the proposal in the letter second read above and requested to sanction a recurring cost of Rs.33,51,600/- for 14 Trauma Registry Assistant during the year 2023-2024. In this regard, remarks were called for from the Project Director, Tamil Nadu Health System Reform Program in the Government letter third read above.

2. The Project Director, Tamil Nadu Health System Reform Program in the letter fourth read above has sent a proposal and stated that their Project (TNHSRP) has been working towards improved provision of quality trauma care services. One of the Disbursement Linked Indicator (DLI) of Project is the Establishment of Trauma Registry. It is essential to have concrete data on the pre-hospital, hospital management and disposition of all trauma cases for analysis and improvement of trauma care. As a part of World Bank DLI (4.1), establishment of Trauma Registry in 54 Trauma Care Centers has been achieved and claims received from World Bank. In addition to the Disbursement Linked Indicator, Trauma Registry has been established in additional 36 Trauma Care Centers making a total of 90 Trauma Care Centres.

3. The Project Director, Tamil Nadu Health System Reform Program has further stated that the Tamil Nadu Road Safety Department has been sanction of Rs.1,92,15,120/- towards the establishment of IT based trauma registry in 47 Director of Medical and Rural Health Services Tamilnadu Accident and Emergency Care Initiative centres 1 Director of Medical Education and Research Tamilnadu

Accident and Emergency Care Initiative centre for additional human resources (Consultant, Trauma Registry Assistant), Hardware's etc. However, in the reference first read above, the Government orders issued towards recurring cost for only 37 Trauma Care Centers at a cost of Rs.1.05 Crores. Hence, it is proposed towards the recurring cost for the salary of the Trauma Registry Assistants at a cost of Rs.0.67 crore for 2 years.

4. The Project Director, Tamil Nadu Health System Reform Program has furnished the recurring cost for the above 14 Trauma Registry Assistant during the year 2023-2025 (For 2 years) as follows:-
