ORDER:

In the Government Order first read above, sanction of Rs.21,93,50,000/- crore has been sanctioned towards construction of Isolation block in Government Hospital for Thoracic Medicine at Tambaram in Chengalpattu District.

2. The Government Hospital for Thoracic Medicine (GHTM) is established in 1928, functioning exclusively for treatment of TB – Tuberculosis patients. It is a tertiary care centre treating patients with all types of lung diseases including infectious (Tuberculosis & Retroviral diseases) and non-infectious lung diseases (Chronic Obstructive Pulmonary Disease), Bronchial Asthma, Allergic Bronchitis, Bronchiectasis Pneumonia, Interstitial Lung Diseases, Lung Malignancies and all types of Respiratory Failure)

3. The Government of Tamil Nadu has accorded administrative and financial sanction towards construction of an isolation block in Government Hospital for Thoracic Medicine at Tambaram in Chengalpattu at a cost of Rs.21,93,50,000/- Construction work for the same has been initiated in vacant land at south east corner of Government Hospital for Thoracic Medicine campus. The Civil work of the isolation block has been completed on March 2023 with internal electrification work. However to energize the building. Additional HT cables and transformer are highly essential. In view of effective utilization of the isolation building, a few additional facilities such as Internal Approach road, Medical Gas line, HT Line installation etc., has been proposed by the Director of Medical Education and Research.
