ORDER:

The Hon'ble Minister for Health and Family Welfare has made the following Announcement on the floor of the Tamil Nadu Legislative Assembly:-

2. The Institute of Child Health & Hospital is largest exclusive children's hospital in South East Asia, which provide comprehensive medical care services specifically tailored to children's needs. With 800 to 1000 outpatient daily, it offers a wide range of specialized services including paediatric consultations, diagnostic evaluations, therapies and interventions, hospital receives paediatric medicine, surgery, neurology, oncology specialty cases.

3. As a referral hospital and tertiary centre, the Institute of Child Health serves as a crucial hub for complex paediatric cases, often receiving referrals from primary and secondary healthcare facilities. These advanced diagnostic tools enable the medical team to accurately diagnose and monitor conditions in children, ensuring timely and effective treatment. By integrating cutting-edge technology with expert medical care, the hospital reaffirms its commitment to providing the highest standard of healthcare for children, both regionally and nationally. To meet the demands of such specialized care, the hospital needs advanced equipment like digital X-ray, Picture Archiving and Communication System (PACS), and High-end Doppler machine.

Hence, it has proposed for the Digital X-ray, Picture archiving and communication system (PACS) and High-end Doppler machine to Government Institute of Child Health & Hospital for Children, Egmore, Chennai at cost of Rs.2.25 crores through Tamil Nadu Medical Services Corporation Limited under Tamil Nadu Health System Reform Program fund. Since, the above hospital is also empanelled under Nammai Kaakum-48 - Innuyir Kaapom Thittam, it is essential to strengthen the Radiology Department with necessary provisions.

4. The estimate budget for the said activity as follows:-

5. The State Empowered Committee has approved the above proposal.

6. The Government, after careful examination, have decided to accord sanction for strengthening of Radiology Department in Government Institute of Child Health and Hospital for Children, Egmore, Chennai as follows:-

- i. a sum of Rs.1,99,97,100/- (Rupees One crore ninety nine lakhs ninety seven thousand one hundred only) towards procurement of equipment through Tamil Nadu Medical Services Corporation Limited.
- ii. a sum of Rs.24,99,700/- (Rupees twenty four lakhs ninety nine thousand and seven hundred only) towards Minor civil modification through Public Works Department.
- iii. The Director of Medical Education and Research is authorized to draw and deposit the amount sanctioned in para 6(i) above into the Personal Deposit account of Tamil Nadu Medical Services Corporation Limited.
- iv. The Director of Medical Education and Research is authorized to draw and disburse the amount sanctioned in para 6 (ii) above to execute the work through Public Works Department.

7. The amount sanctioned in para 6(i) and (ii) above shall be debited to the following Head of Account:-

However, this expenditure shall be brought in to the notice of the Legislature by Specific Inclusion in the Supplementary Estimates 2024 – 2025. The Director of Medical Education and Research is also directed to include this expenditure while sending the budget proposals for Revised Estimate / Final Modified Appropriation 2024 – 2025 and also send draft explanatory notes for inclusion of this expenditure in the Supplementary Estimates 2024 – 2025 to Government in Finance (Health – II) Department at an appropriate time without fail.
