#### ORDER:

The Government Medical College and ESI Hospital was established in 1970 and the Medical College was established during 2016. More than 300 students are staying at the hostel for their studies. It is one of the prime Government Hospitals in Coimbatore district serving over Two Lakh population and consists of various Departments like General medicine, General surgery, Orthopaedics, Paediatrics, Family welfare, non-communicable disease clinic, Dental clinic, Psychiatry clinic etc., which provides high quality service to the patients in need. Hence, it is proposed for provision of funds towards Construction of Ladies Hostel Compound Wall at a cost of Rs.64.90 Lakhs at Government Medical College and ESI Hospital, Coimbatore district under Tamil Nadu Health System Reform Program World Bank Funds.

2. The detailed estimate which is works out Rs.64.90 lakh for the year 2024-2025 for the above said activity with the approval obtained from the Engineer-in- Chief and Chief Engineer (General), Public Works Department and countersignature of the Head of the User Department concerned.

3. The State Empowered Committee has approved the above proposal.

4. The Government, after careful examination, have decided to accept the request of the Project Director, Tamil Nadu Health System Reform Program and accordingly issue orders on the following:-

- i. Sanction an amount of Rs.64,90,000/- (Rupees Sixty-Four Lakh and Ninety Thousand only) towards construction of Ladies Hostel Compound Wall at Government Medical College and ESI Hospital, Coimbatore District through Public Works Department.

- ii. The Director of Medical Education and Research is authorized to draw and disburse the amount sanctioned above.
- iii. The Public Works Department is directed to submit the Monthly Expenditure Statement to the Director of Medical Education and Research.
- iv. The Director of Medical Education and Research is directed to maintain a separate account exclusively for Tamil Nadu Health System Reform Program funds in Directorates involved, which should be operated by Joint Signatory.
- v. The Director of Medical Education and Research is instructed that upon completion of the proposed construction work, the signage board with logo of Government of Tamil Nadu and Tamil Nadu Health System Reform Program shall be exhibited mandatory.

5. The amount sanctioned in para 4 (i) above shall be debited to the following Head of Account:-

4210 Capital Outlay on Medical and Public Health – 01 Urban Health Services – 200 Other Health Schemes – Externally Aided Projects – PC Tamil Nadu Health Systems Reforms Project – 416 Major Works – 01 Major works.
