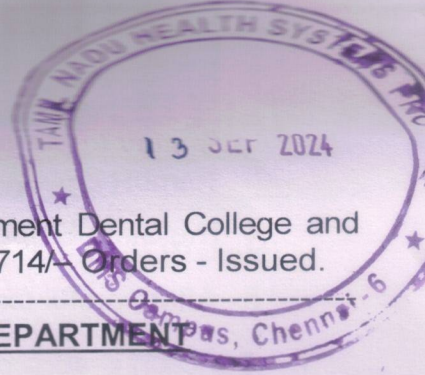

ORDER:

The Hon'ble Minister for Health and Family Welfare has made the following announcement (Announcement No.75) on the floor of the Tamil Nadu Legislative Assembly during the Demand No.19:-

"சென்னை மற்றும் கடலூர் அரசு மருத்துவமனைகளுக்கும், 60 அரசு மருத்துவமனைகளில் செயல்படும் பல் மருத்துவப் பிரிவிற்கும் நவீன உபகரணங்கள் ரூபாய் 11.41 கோடி மதிப்பீட்டில் வழங்கப்படும்."

2. As a part of the above announcement, the Project Director, Tamil Nadu Health System Reform Program has sent a proposal and stated that the Government Dental College Hospital, Cuddalore was established in the year 1980 as a part of Rajah Muthiah Institute of Health Sciences (RMIHS). The institute was subsequently expanded by starting a Medical College. Besides Bachelor of Dental Surgery, Post Graduate degree programs in 8 different specialties are being offered by the Rajah Muthiah Dental College and Hospital. All these programs are recognized by Dental Council of India. This Prestigious institution has given more than 2000 Bachelor of Dental Surgery graduates, More than 800 Master of Dental Surgery stalwarts and more than 60 Research Scholars. Presently Tamil Nadu Dental College and Hospital houses a total of 611 students (Undergraduate 100 / Year and Postgraduate students - 37/year) and 206 Human Resources.

3. The Project Director, Tamil Nadu Health System Reform Program has also stated that Cuddalore Government Dental College and Hospital, Department of Public health dentistry has been conducting regular dental camps since 1985 using mobile dental van in the nearby primary health care centre (Orathur and Pudhuchathiram) and also conducts school and public screening camps for oral diseases and has referred the patients to the Dental Hospital for management of the same. Hence, the Project Director, Tamil Nadu Health System Reform Program has proposed for procurement of equipment at Government Dental College and Hospital, Cuddalore at a total cost of Rs.2.89 crores through Tamil Nadu Medical Services Corporation under Tamil Nadu Health System Reform Program funds as follow:-

4. The State Empowered Committee has approved the above proposal.
5. After careful examination, the Government issued the following orders:-
- Sanction is accorded for a sum of Rs.2,88,74,714 (Rupees two crore eighty eight lakh seventy four thousand seven hundred and fourteen only) towards procurement of equipment to Government Dental College Hospital, Cuddalore District through Tamil Nadu Medical Services Corporation Limited.
 - The Director of Medical Education and Research is authorized to draw and disburse the amount sanctioned in para 5(i) above and to deposit the same in to the personal deposit account of the Managing Director, Tamil Nadu Medical Services Corporation Limited so as to procure the required equipment.
6. The expenditure sanctioned in para 5(i) above shall be debited to the following head of account:-

“2210 Medical and Public Health – 01- Urban Health Services – Allopathy- 110 Hospitals and Dispensaries - Externally Aided Projects – PE – Tamil Nadu Health System Reforms Project – Administrated by the Director of Medical Education and Research - 319 Machinery and Equipment - 01- Purchase”

7. Necessary additional funds of Rs.2,88,74,714/- will be provided in Revised Estimate/Final Modified Appropriation 2024 - 2025. Pending provision of such funds, the Director of Medical Education and Research is authorized to draw and disburse the sanctioned amount in para 5 above. However, this expenditure shall be brought to the notice of the legislature by way of Specific Inclusion to the Supplementary Estimates 2024-2025. The Director of Medical Education and Research is also requested to include this expenditure while sending the budget proposals for Revised Estimate / Final Modified Appropriation 2024-2025 and also send draft explanatory notes for inclusion of this expenditure in the Supplementary Estimates 2024-2025 to Government in Finance (BG-I/Health-II) Department at an appropriate time without fail.
