ORDER:

The Hon'ble Minister for Health and Family Welfare has made the following announcement (Announcement No.30) on the floor of the Tamil Nadu Legislative Assembly under demand No.19 as follows:-

"மதுரை அரசு இராஜாஜி மருத்துவக் கல்லூரி மருத்துவமனையில் இயற்கை எரிவாயு நிலையம் (Bio–Gas Plant) மற்றும் திருவாரூர் அரசு மருத்துவக் கல்லூரி மருத்துவமனையில் கழிவுநீர் சுத்திகரிப்பு நிலையம் (STP, ETP) ரூபாய் 1.50 கோடி மதிப்பீட்டில் அமைக்கப்படும்."

- 2. As a part of the above announcement, the Project Director, Tamil Nadu Health System Reform Program has sent a proposal towards construction of Sewage Treatment plant (500 KLD) at a cost of Rs.1,43,85,000/- in Tiruvarur Medical College and Hospital, Tiruvarur District.
- 3. The Project Director, Tamil Nadu Health System Reform Program has stated that the Government Tiruvarur Medical College and Hospital was established in 2010. It is approved by UGC (University Grants Commission) & affiliated by Tamil Nadu Dr.M.G.R.Medical University. The development of the medical field and the treatment procedures has resulted in hospitals consuming a significant amount of water per day and generating a large amount of liquid waste. Hospital sewage is generated in larger quantities from all units of the hospitals, including emergency and first aid, operating rooms, drug treatment, ICU, chemical and biological laboratories, radiology, canteen and laundry activities. Hospital sewage contains various potentially hazardous components that can cause risks to human health and the environment by polluting surface and groundwater. Therefore, treating liquid waste before discharging into general sewage is necessary. As per the BMWM rule 2016, the chemical liquid waste of the hospital must be collected through a separate collection system for pre-treatment.

- 4. The State Empowered Committee has approved the above proposal.
- 5. The Government, after careful examination, have decided to accept the request of the Project Director, Tamil Nadu Health System Reform Program and accordingly issue orders on the following:-
 - Sanction is accorded for a sum of Rs.1,43,85,000/- (Rupees One crore forty three lakhs and eighty five thousand only) towards construction of Sewage Treatment Plant (500 KLD capacity) in Tiruvarur Medical College and Hospital, Tiruvarur District through Public Works Department.
 - ii) The Director of Medical of Education and Research is authorized to draw and disburse the amount sanctioned in para 5(i) above.
 - 6. The expenditure sanctioned in para 5(i) above shall be debited under the following Head of Account:-
