ORDER:

In the Government orders first read above, an administrative sanction has been accorded for a sum of Rs.5.09 crore towards constructions of additional floor in the PG Academic Block and Ladies Hostel along with the provision of equipment (Ultrasonogram) to Government Siddha Medical College, Arumbakkam, Chennai and minor civil works at floors situated over the Government Siddha Medical College, Arumbakkam, Chennai through Public Works Department and financial sanction was accorded for a sum of Rs.1,40,00,000/- (Rupees one crore forty lakh only) for the financial year 2023-2024.

2. In the letter second read above, the Project Director, Tamil Nadu Health System Reform Program has stated that the Engineer in Chief has informed that a sum of Rs.9,99,000/- was incurred for civil works during the financial year 2023 - 2024. A sum of Rs.1,00,00,000/- (Rupees One Crore Only) has been allocated in BE 2024-2025, which has been fully utilized. Hence, he has requested to sanction the remaining amount of Rs.3,69,01,000/- for the completion of the civil works towards the construction of additional floor in PG academic block and in Ladies Hostel in Government Siddha Medical College, Arumbakkam, Chennai.

3. The Project Director, Tamil Nadu Health System Reform Program has requested to accord financial sanction for a sum of Rs.3,69,01,000/- for the completion of the civil works.

4. The Government, after careful examination, have decided to accord financial sanction for a sum of Rs.3,69,01,000/- (Rupees Three Crore Sixty Nine Lakh and One Thousand Only) towards construction of additional floor in the PG Academic Block and

in Ladies Hostel to Government Siddha Medical College, Arumbakkam, Chennai through Public Works Department.

5. The expenditure sanctioned in para 4 above shall be debited to the following head of account:-

"4210 capital Outlay on Medical and Public Health – 03
Medical Education Training and Research – 104 Siddha –
State's Expenditure – JA Buildings – 416 Major Works – 01-
Major Works"

6. Necessary additional funds of Rs.3,69,01,000/- will be provided in Revised Estimate / Final Modified Appropriation 2024-2025. Pending provision of such funds, the Director of Indian Medicine and Homeopathy is authorized to draw and disburse the above sanctioned amount in para 4 above. However, this expenditure shall be brought to the notice of the Legislature by ~~Specific Inclusion~~ in the Supplementary Estimates 2024-2025. The Director of Indian Medicine and Homeopathy is also directed to include this expenditure while sending the budget proposals for Revised Estimate / Final Modified Appropriation 2024-2025 and also send draft explanatory notes for inclusion of this expenditure in the Supplementary Estimates 2024-2025 to Government in Finance (BG-I/Health-II) Department at an appropriate time without fail.
