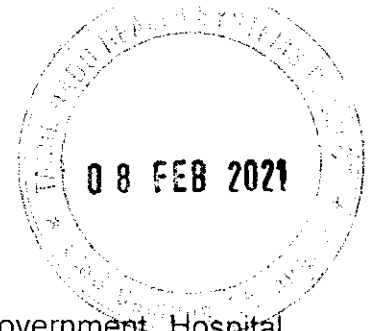

**ORDER:**

During the inaugural function of the Tirupathur new District has made the following announcement:-

“OP Block and ICU ward at a cost of Rs.750 lakh will be constructed in Government Hospital, Ambur”

2. In the letter read above, the Director of Medical and Rural Health Services has stated that the Government Hospital, Ambur was started as a Community Health Care and then it was upgraded as a Non-Taluk Government Hospital in 1967, later upgraded as Taluk Hospital. It is situated at a distance of 60 Kms from Government Medical College Hospital, Vellore and 20 Kms from Government Hospital, Vaniyambadi and the Hospital is situated first 500 meters from Ambur bus stand.

3. The Director of Medical and Rural Health Services has therefore sent proposal along with the Rough Cost Estimate prepared by the Engineer-in-Chief (Building) and Chief Engineer (Buildings) Public Works Department duly Counter Signed by him for a sum of Rs.825 lakhs for construction of OP Block and ICU ward in Government Hospital, Ambur, Thirupathur District as announced by the Hon'ble Chief Minister.

4. The Government have examined the proposal of the Director of Medical and Rural Health Services in detail. Accordingly, the Government issues the following orders:-

- i. The Government accord Administrative sanction for a sum of Rs.9.98 crore (Rupees Nine crore ninety eight lakh only) for the construction of Additional building to Government Hospital, Ambur, Thirupathur District in PIP 2021-2022.
- ii. The Director of Medical and Rural Health Services is directed to send necessary proposal to the Mission Director, National Health Mission to include proposal in PIP 2021-2022.
- iii. The Mission Director, National Health Mission is directed to include this proposal in PIP 2021-2022 and inform the outcome of the inclusion in the PIP to the Director of Medical and Rural Health Services.
- iv. If the above proposal is not approved under PIP, the Director of Medical and Rural Health Services shall send proposal to the Tamil Nadu Health System Reform Program. The Project Director, Tamil Nadu Health System Reform Program shall include the above proposal in the Tamil Nadu Health System Reform Program Fund 2021-2022.

5. This orders issues with the concurrence of Finance Department vide its U.O.No.14/JS(KU) Health-II/2021, dated 02.02.2021.
