ORDER:

The Hon'ble Minister for Health and Family Welfare has made the following Announcement in the floor of the Tamil Nadu Legislative Assembly during the Demand No. 19.

(Announcement No.74):

"மார்பக புற்றுநோய் மற்றும் கருப்பைவாய் புற்றுநோய் கண்டறியும் மற்றும் சிகிச்சை கருவிகள் ரூபாய் 6.98 கோடி செலவில் வழங்கப்படும்".

2. Based on the above announcement, the Project Director, Tamil Nadu Health System Reform Program has sent proposal approved in the State Empowered Committee meeting held on 27.08.2021 for Strengthening Management of Non-Communicable Diseases and stated that STEPS survey 2019 - 2020 of Non-Communicable diseases (NCD) risk factors in Tamil Nadu, India was carried out from January 2020 – March 2020. The results of the survey show is detailed as below:

Thus, the prevention and management of NCDs is of prime importance as these diseases lower the quality of life, impair the economic growth and place a heavy, rising demand on families.

- 3. The Project Director, Tamil Nadu Health System Reform Program has stated that to improve screening, treatment, follow-up and control for NCDs, the Program will support the implementation and strengthening of Population-based screening. Strengthening of PHCs will aim to improve treatment and follow-up for patients diagnosed with NCDs. In addition, the Program will contribute to strengthening lab services. It will also support the newer initiative "Makkalai Thaedi Maruthuvam" scheme, which will be a holistic "Home-Based Care Service" offering a comprehensive range of services including NCD drug delivery, palliative care services and physiotherapy sessions including referral for other essential services.
- 4. The Project Director, Tamil Nadu Health System Reform Program has furnished the total cost of the above proposal as detailed below:-

- 5. The Project Director, Tamil Nadu Health System Reform Program has stated that the fact that whether "Patients with Hypertension and Diabetes whose blood pressure and blood sugar are under control" would be evidenced by a periodical STEPS survey, the Government have accorded permission to the Project Director, Tamil Nadu Health System Reform Program to conduct the STEPS survey in the years 1, 3 and 5 (3 rounds) through a detailed Terms of Reference vetted by the World Bank and has proposed to conduct the 2nd round of STEPS Survey in the year 2022 - 2023 to study the control of Hypertension and Diabetes among the population.
- The Project Director, Tamil Nadu Health System Reform Program has requested the Government to issue orders in this regard.
- 7. The Government after careful consideration of the proposal of the Project Director, Tamil Nadu Health System Reform Program have decided to accept the same and accordingly issue the following orders:-
 - Sanction is accorded for a sum of Rs.68,79,62,099/- (Rupees Sixty Eight Crore. Seventy Nine Lakh, Sixty Two Thousand and Ninety Nine only) to purchase of equipment, reagents, drugs and supplies for the facilities under all directorates through Mission Director, National Health Mission - State Health Society and the Project Director, Tamil Nadu Health System Reform Program is permitted to carry out the activities for this program.
 - Sanction is accorded for a sum of Rs.1,80,00,000/- (Rupees One Crore and Eighty Lakh only) to the Project Director, Tamil Nadu Health System Reform Program to carry out the activities to conduct the 2nd round of STEPS Survey.
- The Mission Director, National Health Mission State Health Society is permitted to procure the equipment, drugs, reagents required for the facilities under all Directorates for the program through Tamil Nadu Medical Services Corporation Limited.
- The Project Director, Tamil Nadu Health System Reform Program is permitted to give incentives to Tamil Nadu Corporation for Development of Women for Women Health Volunteers through the National Health Mission - State Health Society.
- The Project Director, Tamil Nadu Health System Reform Program is permitted to carry out printing of NCD registers through the Mission Director, National Health Mission - State Health Society.
- The Section Officer (Bills) of Health and Family Welfare Department of Secretariat, Chennai is permitted to draw the amount sanctioned in para 7 (i) above from the Pay and Account Officer (Secretariat) and disburse to the Mission Director, National Health Mission - Tamil Nadu through ECS under the following Bank Account:-
