ORDER:

The Hon'ble Minister for Health and Family Welfare has made the following Announcement in the floor of the Tamil Nadu Legislative Assembly during the Demand No.19.

Announcement No.77

"சிவகங்கை அரசு மருத்துவக்கல்லூரி மருத்துவமனைக்கு சிறார்களுக்கான காதுவால் நரம்பு உள்வைப்பு (Cochlear Implant) அறுவை சிகிச்சைக்கான நவீன மருத்துவ உபகரணங்கள் வழங்கப்படும்".

2. Based on the above, the Project Director, Tamil Nadu Health System Reform Program in the letter read above has detailed the statistical report on the ENT performance, Chief Minister's Comprehensive Health Insurance Scheme performance of the Sivagangai Medical College Hospital and justified the requirement of the Cochlear Implant equipment to the institution and furnished the estimated budget for the activity works out to the expenditure, as follows:-

3. The State Empowered Committee has approved the above proposal.

4. The Project Director, Tamil Nadu Health System Reform Program therefore has requested the Government to issue necessary orders in this regard.



5. After careful consideration of the proposal of the Project Director, Tamil Nadu Health System Reform Program, the Government have decided to accept the same and accordingly issue the following orders:-

- i) Sanction is accorded for a sum of Rs.93,58,000/- (Rupees Ninety three lakhs fifty eight thousand only) towards the Cochlear implant surgery equipment for Government Medical College Hospital, Sivagangai.
- ii) The Director of Medical Education and Research is authorized to draw the amount sanctioned above and deposit the same in to the Personal Deposit account of the Managing Director, Tamil Nadu Medical Services Corporation Limited so as to procure the equipment.

6. The expenditure sanctioned in para 5 (i) above shall be debited to the following head of account:-

2210 – Medical and Public Health – 01 Urban Health Services - Allopathy – 110 Hospitals and Dispensaries – Externally Aided Project – PE – Tamil Nadu Health System Reforms Project – Administrated by the Director of Medical Education – 319 Machinery and Equipment – 01Purchase

(DPC 2210 - 01-110 - PE-31901)

7. Necessary funds of Rs.93,58,000/- will be provided in Revised Estimate / Final Modified Appropriation 2023-2024. Pending provision of such funds, the Director of Medical Education and Research is authorized to draw and disburse the above sanctioned amount. However, this expenditure shall be brought to the notice of the Legislature by Specific Inclusion in the Supplementary Estimates 2023-2024. The Director of Medical Education and Research is also requested to include this expenditure while sending the budget proposals for Revised Estimates / Final Modified Appropriation 2023-2024 and also send draft explanatory notes for inclusion of this expenditure in the Supplementary Estimates 2023-2024 to Government in Finance (BG-I / Health-II) Department at an appropriate time without fail.
