From the Project Director, Tamil Nadu Health System Reform Program, letter Ref.No.5086/TNHSRP/PMU/TRAUMA/2022, Dated 23.05.2022.

ORDER:

The Project Director, Tamil Nadu Health System Reform Program has stated that the Tamil Nadu Health System Reform Program has been working towards improved provision of quality trauma care services. During the year 2019-2020, as a part of first year activity, the trauma registry was developed and established in 2 centers (Government Vellore Medical College, Vellore and Government Hospital, Ambur) on a pilot basis and as a part of second year activity (2020-2021), the IT based trauma registry was established in 26 trauma care centers and the Disbursement from World Bank was claimed. During the year 2021-2022, the trauma registry was established in 11 new Medical College Hospitals. Since to achieve the Year 4 (2022-2023) target towards the DLI-4.1 Trauma Registry and to claim the Disbursement from the World Bank, it is essential to establish the Trauma Registry in 4 Government District Headquarters Hospital (Level II Centres).

2. According to the above, she has proposed to establish Trauma Registry in following 4 Government District Headquarters Hospitals.

- (1) Government District Headquarters Hospital, Cuddalore
- (2) Government District Headquarters Hospital, Kanchipuram
- (3) Government District Headquarters Hospital, Erode
- (4) Government District Headquarters Hospital, Perambalur

She has furnished vital statistics and general performance of the above 4 Government District Headquarters Hospitals. The Qualification, Job Functions and Mode of Appointment for Trauma Registry Assistants (Staff Nurse) as furnished as follows:-

Qualification:

He / She should have completed Diploma / Degree in Nursing with Computer knowledge.

Job functions:

1. He / She will collect and enter the relevant registry data from time of incidence, Pre hospital, in hospital course till disposal of the patient
2. He / She will collate and analyze the data for the given indicators periodically in co-ordination with the institutional authorities and also with the State registry team
3. He / She will compile and collate trauma related data from other sources like RADMS, IRAD, 108 EMS, etc..
4. He / She will also assist in nursing related work in Emergency Room-relevant to trauma registry activities

Mode of Appointment:

Contract by the concerned Joint Director of Health Services of the Districts through the District Health Society.

4. The Project Director, Tamil Nadu Health System Reform Program has stated that the above proposal has been approved in the State Empowered Committee and has requested the Government to issue necessary orders in this regard.

5. The Government after careful consideration of the proposal of the Project Director, Tamil Nadu Health System Reform Program have decided to accept the same and accordingly issue the following orders:-

- (i) Sanction is accorded to establish Trauma Registry in 4 Government District Head Quarters Hospitals mentioned at para 2 above.
- (ii) Sanction is accorded for a sum of Rs.15,18,720/- (Rupees Fifteen Lakhs Eighteen Thousand Seven Hundred and Twenty Only) towards the Salary of Trauma Registry Assistant (Staff Nurse) including EPF.
- (iii) Sanction is accorded for a sum of Rs.5,60,000/- (Rupees Five Lakhs and Sixty Thousand Only) towards the Procurement of Hardwares (Desktop, Laptop, Printer, Scanner) through GEM Portal / ELCOT.
- (iv) The Director of Medical and Rural Health Services is authorized to draw and disburse the amount sanctioned in para 5 ((ii) and (iii) above
- (v) A separate account to be maintained exclusively for Tamil Nadu Health Systems Reforms Project funds in Directorates and facilities involved which should be operated by joint signatory.

6. The expenditure sanctioned in para 5 (ii) above shall be debited to the following head of account:-

2210 – Medical and Public Health – 01 Urban Health Services - Allopathy – 110 Hospitals and Dispensaries – Externally Aided Project – PD – Tamil Nadu Health System Reforms Project – Administrated by the Director of Medical and Rural Health Services – 333 Payments for Professional and Special Services – 04 Contract Payment.

7. The expenditure sanctioned in para 5 (iii) above shall be debited to the following head of account:-

2210 – Medical and Public Health – 01 Urban Health Services - Allopathy – 110 Hospitals and Dispensaries – Externally Aided Projects – PD – Tamil Nadu Health System Reforms Project – Administrated by the Director of Medical and Rural Health Services – 376 Computer and Accessories - 01 Purchase.

(IFHRMS DPC: 2210 - 01 -110 - PD - 37601) - Rs.5,69,000/-

8. Necessary funds of Rs.20,78,720/- will be provided in RE/FMA 2022–2023, Pending provision of such funds, the Director of Medical and Rural Health Services is authorized to draw and disburse the above sanctioned amount. However, this expenditure shall be brought to the notice of the Legislature by Specific Inclusion in the Supplementary Estimates 2022-2023. The Director of Medical and Rural Health Services is also requested to include this expenditure while sending the budget proposals for RE/FMA 2022-2023 and also send necessary draft explanatory notes for inclusion of this expenditure in the Supplementary Estimates 2022-2023 to Government in Finance (Budget-I / Health-II) Department an appropriate time without fail.


