ORDER:

In the Government Order first read above, the Government have issued orders regarding the Hon'ble Chief Minister's flagship scheme "Makkalai Thedi Maruthuvam" (MTM) to address the increasing burden due to Non-Communicable Diseases (NCD) by focusing on community-based interventions to improve compliance and control of disease. This scheme is implemented through the Director of Public Health and Preventive Medicine, Director of Medical and Rural Health Services and Director of Medical Education as per the roles assigned in that Government Order. In the Government Order second and third read above, the Government have issued orders, among others Rs.42.32 Crore was sanctioned towards implementation of Makkalai Thedi Maruthuvam scheme and Rs.70.60 Crore was sanctioned towards the purchase of equipment, reagents, drugs and carry out the activities to follow up and control the Non-Communicable Diseases as the support for the Makkalai Thedi Maruthuvam scheme respectively.

2. The Project Director, Tamil Nadu Health System Reform Program in her letter fourth read above has stated that, the objectives of the "Makkalai Thedi Maruthuvam" program are largely based on the results from the STEPS Survey by Tamil Nadu Health System Reform Program in 2020 which has indicated the low control rates for Hypertension and Diabetes, now has been expanded in a phased manner across 385 rural blocks covering 8713 Health Sub Centres and 21 corporations covering 460 Urban Primary Health Centres.

3. The Project Director, Tamil Nadu Health System Reform Program has furnished the details of the activities under Makkalai Thedi Maruthuvam Scheme like

provision of incentives to Palliative care nurses and Physiotherapists, distribution of drug boxes and transportation services are to be continued in all blocks/sectors to ensure delivery of quality health services.

4. The Project Director, Tamil Nadu Health System Reform has proposed to provide the funds to ease the certain activities as detailed in annexure to this order and worked out the cost involved in the above activities are derived as follows:-

5. The Project Director, Tamil Nadu Health System Reform Program has stated that the State Empowered Committee had approved the above proposal and requested the Government to issue necessary orders in this regard.

6. After careful consideration of the proposal of the Project Director, Tamil Nadu Health System Reform Program, the Government have decided to accept the same and accordingly issue the following orders:-

- (i) Sanction is accorded for a sum of Rs.44,68,90,500/- (Forty four crore sixty eight lakh ninety thousand and five hundred only) towards the strengthening of Makkalai Thedi Maruthuvam Scheme for the activities mentioned in the table at para 4 above through National Health Mission – Tamil Nadu.
- (ii) Sanction is accorded for a sum of Rs.28,27,95,896/- (Rupees Twenty eight crore twenty seven lakh ninety five thousand eight hundred and ninety six only) towards the strengthening of Makkalai Thedi Maruthuvam Scheme through Tamil Nadu Health System Reform Program.
- (iii) The Section officer (Bills) of Health and Family Welfare Department, Secretariat, Chennai –9 is permitted to draw the amount sanctioned in para 6 (i) above from the Pay and Account Officer (Secretariat) and disburse to the Mission Director, National Health Mission – Tamil Nadu through ECS under the following Bank Account:-

- (vi) The Project Director, Tamil Nadu Health System Reform Program is permitted to give incentives to Women Health Volunteers through Tamil Nadu Corporation for Development of Women in collaboration with the National Health Mission – State Health Society.
