ORDER:

The Hon'ble Minister for Health and Family Welfare has made the following Announcement in the floor of the Tamil Nadu Legislative Assembly during the Demand No.19.

Announcement No.4:-

2. Based on the above announcement, the Project Director, Tamil Nadu Health System Reform Program has sent a proposal to construct a New Hospital Building in Uthiramerur Government Hospital, Kanchipuram District and furnished the vital statistics and general performance of the above said hospital.

3. The Project Director, Tamil Nadu Health System Reform Program has furnished the particulars of Area of Construction detailed below:

4. The Project Director, Tamil Nadu Health System Reforms Program has stated that the above proposal has been approved in the State Empowered Committee and hence requested the Government to issue necessary orders in this regard.

5. The Government after careful consideration of the proposal of the Project Director, Tamil Nadu Health System Reform Program have decided to accept the same and accordingly issue the following orders:-

- (i) Sanction is accorded for a sum of Rs.10,00,00,000/- (Rupees Ten Crore only) towards the construction of new hospital building at Uthiramerur Government Hospital, Kanchipuram District through PWD (Medical Wing).
- (ii) The Director of Medical and Rural Health Services is authorized to draw and disburse the amount sanctioned.
- (iii) A separate account to be maintained exclusively for Tamil Nadu Health System Reform Program funds in Directorates, Districts and Facilities (till beneficiary level if needed) involved, which should be operated by Joint Signatory.

6. The expenditure sanctioned in para 5(i) above shall be debited to the following head of account:-

4210 – Capital Outlay on Medical and Public Health – 01 Urban Health Services – 200 Other Health Schemes – Externally Aided Projects – PD Tamil Nadu Health System Reforms Project – Administrated by Director of Medical and Rural Health Service - 416 Major Works – 01 Major Works.

7. The expenditure sanctioned in para-5 (i) above shall constitute an item of "New Instrument of Service" and the approval of Legislature will be obtained in due course. Pending approval of the Legislature, the expenditure may be initially met by drawal of an advance from the Contingency Fund. The Director of Medical and Rural Health Services is directed to calculate the actual amount required for the period upto next Supplementary Estimates and apply for sanction of the same as advance from the Contingency Fund to Finance (BG.I) Department directly in Form A appended to the Tamil Nadu Contingency Fund Rules 1963 along with a copy of this order. Orders for sanction of an advance from the Contingency Fund will be issued from Finance (BG.I) Department. The Director of Medical and Rural Health Services is requested to send necessary explanatory notes to include the above expenditure in the Supplementary Estimates for the year 2022-2023 to Finance (BG-I/Health-II) Department at the appropriate time without fail.

8. This order issues with the concurrence of the Finance Department vide its U.O.No.43916/Finance (Health-II)/2022, Dated:27.09.2022 and ASL No.1336 (one thousand three hundred and thirty six) (IFHRMS ASL No.2022091336).
