From the Project Director, Tamil Nadu Health System Reform Program Letter Ref.No.12316/TNHSRP/PMU/2022, Dated 28.12.2022.

ORDER:

The Project Director, Tamil Nadu Health System Reform Program in the letter read above, has stated that the Tamil Nadu Government Dental College is functioning from the year 1953, which is in a damaged condition. There are more Female students studying compared to males, the intended men's hostel is now used as ladies' hostel. The old hospital building is modified with partitions and used as men's hostel. There is no vacant land available in the campus to construct the new building for hostel. Hence, Demolition of old Building and Construction of New Ladies Hostel for PG and UG students at the hostel campus of Tamil Nadu Government Dental College & Hospital, Chennai is proposed.

2. The Project Director, Tamil Nadu Health System Reform Program has furnished the HR details, justification for the essentiality to construct the Stilt Floor with G+6 Floors for Ladies Hostel Building at the Hostel campus in the estimate as follows:-

3. The State Empowered Committee headed by the Chief Secretary has approved the proposal and hence the Project Director, Tamil Nadu Health System Reform Program has requested the Government to issue the orders in this regard.

4. The Government after careful consideration of the proposal of the Project Director, Tamil Nadu Health System Reform Program have decided to accept the same and accordingly issue the following orders:-

- i. Administrative sanction is accorded for a sum of Rs.64.90 Crore (Rupees Sixty-four crore and ninety lakh only) towards the Construction of Ladies Hostel Building for PG & UG students at Government Dental College Hostel campus, Chennai (Stilt Floor, G+6 floors) through Public Works Department. Further, Financial sanction is accorded for a sum of Rs.46.00 Crore (Rupees Forty six crore only) for the year 2023-2024. The balance amount of Rs.18.90 Crore will be released in the financial year 2024-2025.
- ii. The Director of Medical Education and Research is permitted to draw and disburse an amount sanctioned at para 4(i) above.
- iii. The Public Work Department is instructed that the materials retrieved during the demolition of the old building should be duly credited to the Government account and also to submit the monthly expenditure statement.
- iv. The Funds shall be booked under the State Share Component of Tamil Nadu Health System Reform Program. A separate account to be maintained exclusively for Tamil Nadu Health System Reform Program funds in Directorates and facilities involved which should be operated by joint signatory.

5. The expenditure sanctioned in para 4 (i) above shall be debited to the following head of account:-

4210 Capital Outlay on Medical and Public Health - 01 Urban Health Services
– 200 Other Health Schemes - External Aided Projects – PC Tamil Nadu Health
Systems Reforms Project -416 Major works – 01 Major works
(DPC 4210 01 200 PC 41601)

6. Necessary funds of Rs.46,00,00,000/- will be provided in Revised Estimate/ Final Modified Appropriation 2023 – 2024. Pending provision of such funds, the Director of Medical Education and Research is authorized to draw and disburse the above sanctioned amount in para 4 above. However, this expenditure shall be brought to the notice of the Legislature by Specific Inclusion in the Supplementary Estimates 2023-2024. The Director of Medical Education and Research is also requested to include this expenditure while sending the budget proposals for Revised Estimate / Final Modified Appropriation 2023 – 2024 and also send necessary draft explanatory notes for specific inclusion of this expenditure in the Supplementary Estimates 2023-2024 to Government in Finance (BG-I/Health-I) Department at an appropriate time without fail.
