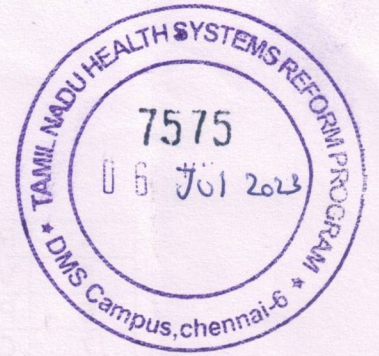

**ORDER:**

The Project Director, Tamil Nadu Health System Reform Program in the letter read above, has stated that Day Care Chemotherapy Centres are being established in District Head Quarters Hospitals to provide continuation of simple chemo regimens after the initial cycle being started at a tertiary care hospital. This reduces the out of Pocket Expenditure for each chemo cycle in terms of travel and accommodation for the patient and their attenders. As a Day Care Chemotherapy Centre was already established in Villupuram District at Kallakurichi Government Hospital in the year 2018 which became a separate district later, it is proposed to establish a new one for the Villupuram District at Tindivanam Government District Head Quarters Hospital. The required equipment to establish a Day Care Chemotherapy Centre is furnished as follows:-

The drugs are requested to the Chemo Regimen for Day Care Chemotherapy Center as follows:-

6.	Prednisolone
7.	Cisplatin
8.	Gemcitabine
9.	Etoposide

The sanction of recurring cost for oncology drugs for the Day Care Chemotherapy Centre after establishment, can be met under the NPCDCS head through NHM after necessary approval from the Government. No additional Human Resource will be provided for this program for this facility. The existing physician and existing staff nurse shall be trained in Chemotherapy at the department of Medical Oncology in nearby Medical College Hospitals for 10 days.

2. The estimated budget for the activity as furnished as follows:-

3. The above proposal was approved by the State Empowered Committee and hence the Project Director, Tamil Nadu Health System Reform Program has requested the Government to issue the orders in this regard.

4. The Government, after careful consideration of the proposal of the Project Director, Tamil Nadu Health System Reform Program have decided to accept the same and accordingly issue the following orders:-

- i. Sanction is accorded for a sum of Rs.4,15,000/- (Rupees Four lakh fifteen thousand only) towards the establishment of Day Care Chemotherapy Centre in Tindivanam Government District Head Quarters Hospital in Villupuram district.
- ii. The Director of Medical and Rural Health Services is authorized to draw the amount sanctioned above and deposit the same in to the Personal Deposit account of the Managing Director, Tamil Nadu Medical Services Corporation Limited so as to procure the equipment listed in para 2 above.
- iii. The Director of Medical and Rural Health Services is directed to include this facility in the list of hospitals supported by National Health Mission for drugs through Tamil Nadu Medical Services Corporation Limited.
- iv. A separate account to be maintained exclusively for Tamil Nadu Health System Reform Program funds in Directorate, District and the facility (till beneficiary level if needed) involved, which should be operated by Joint Signatory



5. The expenditure sanctioned in para 4 (i) above shall be debited to the following head of account:-

2210 – Medical and Public Health – 01 Urban Health Services - Allopathy – 110 Hospitals and Dispensaries – Externally Aided Project – PD – Tamil Nadu Health System Reform Project – Administrated by the Director of Medical and Rural Health Services – 319 Machinery and Equipments – 01 Purchase

6. Necessary funds of Rs.4,15,000/- will be provided in Revised Estimate / Final Modified Appropriation 2023–2024. Pending provision of such funds, the Director of Medical and Rural Health Services is authorized to draw and disburse the above sanctioned amount. However, this expenditure shall be brought to the notice of the Legislature by Specific Inclusion in the Supplementary Estimates 2023-2024. The Director of Medical and Rural Health Services is also requested to include this expenditure while sending the budget proposals for Revised Estimate / Final Modified Appropriation 2023-2024 and also send draft explanatory notes for inclusion of this expenditure in the Supplementary Estimates 2023-2024 to Government in Finance (BG-I/ Health-II) Department at an appropriate time without fail.
