ORDER:

The Hon'ble Minister for Health and Family Welfare has made the following Announcement in the floor of the Tamil Nadu Legislative Assembly during the Demand No.19.

Announcement No.107:-

"உலக வங்கி திட்டத்தில் வரையறுக்கப்பட்ட இலக்குகளின்படி தாய்சேய் நலப்பணிகளின் புள்ளிவிவரங்களை பகுதி சுகாதார செவிலியர்கள் மூலம் உடனுக்குடன் இணையவழி பதிவேற்றம் செய்வதற்கு ரூபாய் 19.86 கோடி மதிப்பீட்டில் உலக வங்கி திட்டத்தின் கீழ் 1,806 ஊரக சுகாதார நிலையங்களுக்கு தலா ஒரு மடிக்கணினி வழங்கப்படும்."

2. Based on the above, the Project Director, Tamil Nadu Health System Reform Program in the letter read above has stated that the Disbursement Linked Indicator (DLI 5) of Utilization of Reproductive and Child Health Services (Antenatal checkup, Immunization and Modern Contraceptive methods) had been achieved as per the National Family Health Survey (NFHS). The disbursement of US\$56,500,000 for the same was claimed from the World Bank. The documentation of performance data was one of the major reasons in achieving the DLI. The Sector Health Nurses (SHNs) and District Maternal and Child Health Officers (DMCHOs) play an important role in implementing all Reproductive and Child Health (RCH) activities and providing all fertility and mortality indicators pertaining to their area. They supervise and verify all the reports prepared by Auxiliary Nurse and Midwife (ANM)/ Village Health Nurse (VHN) pertaining to Maternal and Child Health activities. Also, they prepare various reports regularly and periodically like Health Management Information System (HMIS), Pregnancy and Infant Cohort Monitoring and Evaluation (PICME), Muthulakshmi

Reddy Maternity Benefit Scheme (MRMBS), Pradhan Mantri Matru Vandana Yojana (PMMVY), Infant death, Maternal Death, Janani Suraksha Yojana (JSY), Janani Shishu Suraksha Karyakram (JSSK), Immunization and Health Sub Centre (HSC) wise reports for review. For successfully carrying out the above said activities and to upload the report related to various Reproductive and Child Health services online, provision of laptops to Sector Health Nurses is essential.

3. The Project Director, Tamil Nadu Health System Reform Program has therefore proposed to provide the Laptops to 1807 Sector Health Nurses (SHNs) of the rural Public Health Centres (PHCs) and 45 District Maternal and Child Health Officers (DMCHOs) of Tamil Nadu as annexed to this order and furnished the total expenditure in the activity as follows:-

4. The Project Director, Tamil Nadu Health System Reforms Program has further stated that the State Empowered Committee had approved the proposal and hence requested the Government to issue the necessary orders in this regard.

5. After careful consideration on the request above, the Government have decided to accept the same and issue the following orders:-

- (i) Sanction is accorded for a sum of Rs.15,92,33,627/- (Fifteen Crore Ninety Two lakh Thirty three thousand six hundred and twenty seven only) towards the provision of Laptops with accessories to the 1807 Sector Health Nurses (SHNs) of rural Public Health Centres and 45 District Maternal and Child Health Officers (DMCHOs) of Tamil Nadu (as annexed to this order) through ELCOT
- (ii) The Director of Public Health and Preventive Medicine may be authorized to draw and disburse the amount sanctioned above
- (iii) A separate account to be maintained exclusively for Tamil Nadu Health System Reform Program funds in Directorates, Districts and Facilities (till beneficiary level if needed) involved, which should be operated by Joint Signatory

6. The expenditure sanctioned in para 5(i) above shall be debited to the following head of account:-

2210 Medical and Public Health - 01 Urban Health Services - Allopathy - 200 other Health schemes - Externally Aided Projects - PB - Tamil Nadu Health System Reform Project - Administrated by Director of Public Health - 309 Grants-In-Aid - 03 Grants for Specific Schemes

(DPC 2210 -01-200-PB-309 03)

7. Necessary additional funds of Rs.15,92,33,627/- will be provided in Revised Estimate / Final Modified Appropriation 2023-2024. However, this expenditure shall be brought to the notice of the legislature by Specific Inclusion in the Supplementary Estimates 2023-2024. Pending provision of such funds, the Director of Public Health and Preventive Medicine, is authorized to incur the amount sanctioned in para 5(i) above. The Director of Public Health and Preventive Medicine, is requested to send draft explanatory notes for inclusion of this expenditure in the Supplementary Estimates 2023-2024 and also to include the expenditure while sending the budget proposals for Revised Estimate / Final Modified Appropriation 2023-2024 to Government in Finance (Health-I/BG-I) Department without fail.

8. This order issues with the concurrence of the Finance Department vide its U.O.No.24549/Finance (Health-I)/2023, Dated:04.07.2023 and ASL No.441 (Four Hundred and forty one) (IFHRMS ASL No.2023070441).
