From the Project Director, Tamil Nadu Health System Reform Program Letter Ref.No.4298/TNHSRP/PMU/2022, dated 20.07.2023

#### ORDER:

The Project Director, Tamil Nadu Health System Reform Program in his letter read above has stated that the Government Primary Health Centres (PHCs) at Mannavanur, Dindigul District, Punjai Puliyampatti, Erode District and Pudur Uthamanur, Tiruchirappalli District are located at hilly area of the district and also covers tribal population. Since, the District Government Hospital is situated very far to avail health care services for emergency cases patients report to these Primary Health Centre for first aid and lifesaving services. Hence, it has proposed to construct the Staff Nurse's quarters at Mannavanur Block Primary Health Centre, Dindigul District, Punjai Puliyampatti Upgraded Primary Health Centre, Erode District and Pudur Uthamanur Upgraded Primary Health Centre, Tiruchirappalli District so as to improve the service delivery.

2. The Project Director, Tamil Nadu Health Systems Project has furnished the additional particulars like General Description, Performance, Human Resources of the Primary Health Centre and proposed to construct the Staff Nurse's quarters (Twin type) at the Primary Health Centre with the non-recurring cost is worked out as follows:-

- 3. The State Empowered Committee has approved the above proposal.
- 4. The Project Director, Tamil Nadu Health System Reform Program therefore requested the Government to issue the orders in this regard.
- 5. The Government, after examination, have decided to accept the proposal of the Project Director, Tamil Nadu Health System Reform Program and accordingly issue the following orders:-
  - (i) An administrative sanction is accorded for a sum of Rs.1,16,50,000/-towards the Construction of Staff Nurse's quarters (Twin type) at Mannavanur Block Primary Health Centre, Dindigul District, Punjai Puliyampatti Upgraded Primary Health Centre, Erode District and Pudur Uthamanur Upgraded Primary Health Centre, Tiruchirappalli District.
  - (ii) Financial sanction is accorded for the non-recurring expenditure of Rs.65,00,000/- (Rupees Sixty Five Lakh only) for this financial year 2023-2024 and balance amount will be sanctioned in the next financial year 2024-2025 towards the Construction of Staff Nurse's quarters (Twin type) at Mannavanur Block Primary Health Centre, Dindigul District, Punjai Puliyampatti Upgraded Primary Health Centre, Erode District and Pudur Uthamanur Upgraded Primary Health Centre, Tiruchirappalli District.
  - (iii) The Director of Public Health and Preventive Medicine is authorized to draw and disburse the amount sanctioned above for the activity through Public Work Department (Medical) as mentioned in para 2 above.
  - (iv) A separate SB account to be maintained exclusively for Tamil Nadu Health System Reform Program funds in Directorate / District Health Society and facilities involved which should be operated by Joint Signatory.
- 6. The expenditure sanctioned in para 5(ii) above shall be debited to the following head of account:-
  - 4210 Capital Outlay on Medical and Public Health 04 Public Health Services 200 Other Programmes Externally Aided Projects PD Tamil Nadu Health System Reform Project Director of Public Health and Preventive Medicine 416 Major Works 01 Major Works. (DPC 4210-04-200-PD-41601)
- 7. Necessary funds of Rs:65,00,000/- will be provided in Revised Estimate/Final Modified Appropriation 2023-2024. Pending provision of such funds, the Director of Public Health and Preventive Medicine is authorized to draw and disburse the above sanctioned amount. However, this expenditure shall be brought to the notice of the Legislature by Specific Inclusion in the Supplementary Estimates 2023-2024. The Director of Public Health and Preventive Medicine is also requested to include this expenditure while sending the budget proposals for Revised Estimate/Final Modified Appropriation 2023-2024 and also send draft explanatory notes for inclusion of this expenditure in the Supplementary Estimates 2023-2024 to Government in Finance (BG-I/Health-II) Department at an appropriate time without fail.
