#### ORDER:

The Hon'ble Minister for Health and Family Welfare has made the following Announcement in the floor of the Tamil Nadu Legislative Assembly during the Demand No.19.

#### Announcement No.37:-

"புதுக்கோட்டை மாவட்டம் – காரையூர் மற்றும் புதுநகர், சிவகங்கை மாவட்டம் – பூவந்தி, விருதுநகர் மாவட்டம் – தாயில்பட்டி மற்றும் ஜமீன் கொல்லன்கொண்டான், திருவண்ணாமலை மாவட்டம் – மங்களம், தூத்துக்குடி மாவட்டம் – புதுக்கோட்டை மற்றும் தென்காசி மாவட்டம் – கெங்கோட்டை மற்றும் தென்காசி மாவட்டம் – செங்கோட்டை ஆகிய ஆரம்ப சுகாதார நிலையங்களில் உலக வங்கி திட்டத்தின் கீழ் ரூ.1.20 கோடி மதிப்பீட்டில் இரத்த சேமிப்பு அலகு நிறுவப்படும்."

- 2. In Government Order first read above, orders were issued regarding the approved and adopted the State and District Health Assemblies. The guidelines has also been issued to the implementation of the Health Assemblies in multiple phases. Accordingly, the first phase was started from the year 2020-2021 by organizing 4 District Health Assemblies and planned about the next phase would be scaled up based on the gained experience of the initial phase.
- 3. In Government Order second read above, orders were issued accorded sanctioning of Rs.30,00,000/- towards conducting the State and District Health

Assemblies for the year 2020-2021 (i.e. 2<sup>nd</sup> year) in Salem, Pudukkottai, Sivagangai and Cuddalore. In the Government Order third read above, orders were issued accorded sanctioning of Rs.72.56 Lakh for conducting Health assemblies in 10 Districts and State Health Assembly for the year 2021-2022 as a 3<sup>rd</sup> year activity in 2022.

4. The Project Director, Tamil Nadu Health System Reform Program in the letter fourth read above, has stated that the Blood Storage Unit is mandatory department as the National Quality Assurance Standards to provide the quality healthcare services and it attempts to bring the potentially life saving benefits of transfusion to the patients who need them by making the blood components available, safe, effective. The easiest way to assure timely availability of blood is to have an appropriate blood storage unit in the facility. She has furnished the justification for the establishment of blood storage unit in certain Community Health Centre / Upgraded Government Primary Health Centre / Government Hospital with a cost of Rs.15 lakhs per unit and has further stated that the State Empowered Committee had approved the proposal for provision of Blood Storage Unit in 8 following Government Health Facilities at the total cost of Rs.1.20 Crore and requested the Government to issue necessary orders in this regard.

- 5. The Project Director, Tamil Nadu Health System Reform Program has further detailed the package of equipment (as annexed in annexure) cost is Rs.11.00 lakhs may be purchased through Tamil Nadu Medical Services Corporation and infrastructure cost is Rs.4.00 lakhs for minor civil and electrical works may be executed locally through District Health Society of the districts concerned as per the requirement of Blood Storage Unit.
- 6. The Government after careful consideration of the proposal of the Project Director, Tamil Nadu Health System Reform Program have decided to accept the same and accordingly issue the following orders:-
  - (i) Sanction is accorded for a sum of Rs.1,20,00,000/- (Rupees One Crore and Twenty lakhs only) for provision of Blood Storage Unit (BSU) in 8 Government Health Facilities mentioned in para 4 above.

- (ii) The Director of Public Health and Preventive Medicine is authorized to draw and disburse the amount of Rs.1,05,00,000/- for 7 Community Health Centres mentioned in para 4 above and purchase the equipment at the rate of 11 lakhs per unit through Tamil Nadu Medical Service Corporation Limited, Chennai and to execute the minor civil & electrical work at the rate of 4 lakhs per unit locally through District Health Society concerned towards the provision of BSU in above said 7 CHC/UPHC.
- (iii) The Director of Medical and Rural Health Services is authorized to draw and disburse the amount of Rs.15,00,000/- and purchase the equipment at the rate of 11 lakhs per unit through Tamil Nadu Medical Service Corporation Limited, Chennai and to execute the minor civil & electrical work at the rate of 4 lakhs per unit locally through concerned JDHS towards the provision of BSU in Shengottai Government Hospital.
- (iv) A separate SB account to be maintained exclusively for Tamil Nadu Health System Reform Program funds in Directorate / District Health Society and facilities involved which should be operated by Joint Signatory.
- 7. For the expenditure of purchase of equipment / minor civil and electrical work sanctioned in para 6 (ii) above shall be debited to the following head of account respectively:-

8. For the expenditure of purchase of equipment / minor civil & electrical work sanctioned in para 6 (iii) above shall be debited to the following head of account respectively:-

- 9. Necessary additional funds of Rs.1,20,00,000/-. Will be provided to RE/FMA 2022-2023. Pending provision of such funds. The Director of Public Health and Preventive Medicine and the Director of Medical and Rural Health Services are authorized to draw and disburse the respective sanctioned amount in para 6 above. However, this expenditure shall be brought to the notice of the legislature by Specific Inclusion in the Supplementary Estimates 2022-2023. The Director of Public Health and Preventive Medicine and the Director of Medical and Rural Health Services are also requested to include this expenditure while sending the budget proposals for RE/FMA 2022-2023 and also send draft explanatory notes for specific inclusion in the Supplementary Estimates 2022-2023 to Government in Finance (BG-I/Health-II) Department at an appropriate time without fail.
