ORDER:

The Government Headquarters Hospital, Pollachi was upgraded as headquarters hospital in 2010 and located near the national highway. It is a secondary care hospital covering a population of around 7,00,000, with approximately 450 In-patients. People from nearby towns, Urban & Rural Government Primary Health Centre and Valparai hill region are being referred to this hospital for treatment and services.

2. In the Government order first read above, sanction is accorded towards HT supply arrangement and double tire panel board at Government Headquarters Hospital, Pollachi in Coimbatore district at a cost of Rs.2,08,96,700/-.

3. A provision have been made for "construction of 20.00m x 7.00m x 4.50m HT room with office room with necessary cable duct in room inside and suitable grill shutter arrangements" for Rs.30.00 lakhs, which is not adequate for completing the construction of the building. Therefore, to improve the infrastructure facilities, it has proposed for additional funds to complete HT Panel room for HT Supply arrangement and double tire panel board in Government district head Quarters Hospital at Pollachi in Coimbatore District, at a cost of Rs.35,17,500/- under Tamil Nadu Health System Reform Program World Bank funds.

4. The State Empowered Committee has approved the above proposal.

5. The Government, after careful examination, have decided to accord sanction for an amount of Rs.35,17,500/- (Rupees Thirty five lakh seventeen thousand and five hundred only) towards additional funds to complete HT panel room for HT supply arrangement and double tire panel board in Government Headquarters Hospital, Pollachi, Coimbatore District through Public Works Department. The Director of Medical and Rural Health Services is authorized to draw and disburse the amount sanctioned above.

6. The expenditure sanctioned in para 5 above shall be debited to the following head of account:-
