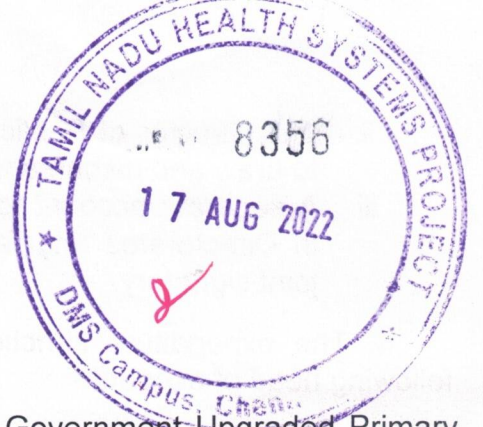

ORDER:

The Hon'ble Minister for Health and Family Welfare has made the following Announcement in the floor of the Tamil Nadu Legislative Assembly during the Demand No.19.

Announcement No.41

“இராமநாதபுரம் மாவட்டம்-உச்சிப்புளி அரசு ஆரம்ப சுகாதார நிலையத்தில் உலக வங்கி திட்டத்தின் கீழ் ரூபாய் 3 இலட்சம் மதிப்பீட்டில் அறுவை சிகிச்சை மேசை (Hydraulic Type) வழங்கப்படும்”.

2. Based on the above announcement, the Project Director, Tamil Nadu Health System Reform Program has sent a letter read above along with the justification, vital statistics and general performance of the Uchipuli Upgraded Primary Health Centre and requested to provide a Hydralic OT Table at cost of Rs.3.00 Lakhs to that Upgraded Primary Health Centre. She has further stated that the State Empowered Committee had approved the proposal for provision of Hydralic OT Table to that Uchipuli Government Upgraded Primary Health Centre and hence requested the Government to issue necessary orders in this regard.

3. The Government after careful consideration of the proposal of the Project Director, Tamil Nadu Health System Reform Program have decided to accept the same and accordingly issue the following orders:-

- i. Sanction is accorded for a sum of non-recurring expenditure of Rs.3,00,000/- (Rupees Three lakhs only) towards the provision of Hydraulic OT Table in Government Upgraded Primary Health Centre (UPHC) Uchipuli Mandapam Block, Ramanathapuram District.

- ii. The Director of Public Health and Preventive Medicine is authorised to draw and disburse the above sanctioned amount.
- iii. A separate account to be maintained exclusively for TNHSRP funds in Directorates and facilities involved which should be operated by joint signatory.

4. The expenditure sanctioned in para 3 (i) above shall be debited to the following head of account:-

2210 – Medical and Public Health – 01 Urban Health Services - Allopathy – 200 Other Health Schemes – Externally Aided Project – PB – Tamil Nadu Health System Reforms Project – Administrated by Director of Public Health – 309 Grants-in-Aid - 03 Grants for Specific Schemes.
