ORDER:

The Project Director, Tamil Nadu Health System Reform Program, in the letter read above, has stated that to cater to the health care needs of people living in rural areas, Primary Health Care Centres are functioning 24 * 7 providing Emergency and Basic Health Care services, thus serving as a Backbone of Public Health care system. The availability of residential facilities in the vicinity of Primary Health Centre's in rural areas is scarce. This affects the constant availability of Staff in the Primary Health Centre area, so the staffs tend to reside in places away from Primary Health Centres. These Primary Health Centres are located away from the town, where transport facilities are not easily accessible. Hence, it has proposed to construct the Staff Nurse's quarters at Manampathy, Innungur, Kallavi, Mohanur, Pongalur, Thirunendugulam, Bojanapuram, Gengavaram, Vellimedupettai so as to improve the service delivery.

2. The Project Director, Tamil Nadu Health Systems Project has furnished the additional particulars like General Performance, Human Resources of the Primary Health Centres and to take up the activity is worked out for the non-recurring expenditure of Rs.2.97 crore as follows:-

3. The State Empowered Committee has approved the above proposal.

4. The Project Director, Tamil Nadu Health System Reform Program has therefore requested the Government to sanction out of Rs.2.97 Crores, a sum of Rs.1.80 crore for this Financial year 2023-2024 and the remaining amount of Rs.1.17 Crores for next Financial year 2024-2025.

5. The Government, after careful examination have decided to accord administrative sanction for a sum of Rs.2.97,00,000/- (Rupees two crore ninety seven lakhs only). Accordingly issue the following orders:-

- i. Sanction is accorded for a non-recurring expenditure of Rs.2,97,00,000/- (Rupees two crore ninety seven lakhs only) towards the construction of Staff Nurse's quarters (Twin type) at Manampathy Upgraded Primary Health Centre, Innungur Upgraded Primary Health Centre, Kallavi Upgraded Primary Health Centre, Mohanur Upgraded Primary Health Centre, Pongalur Upgraded Primary Health Centre, Thirunendugulam Additional Primary Health Centre, Bojanapuram Additional Primary Health Centre, Gengavaram Additional Primary Health Centre, Vellimedupettai Additional Primary Health Centre.
- ii. The Director of Public Health and Preventive Medicine is authorized to draw and disburse the above sanctioned amount for the activity as mentioned in para 2 above.
- iii. A separate Savings Bank account to be maintained exclusively for Tamil Nadu Health System Reform Program funds in Directorate / District Health Society and facilities involved which should be operated by Joint Signatory.

6. The expenditure sanctioned in para 5(i) above shall be debited to the following head of account:-

"4210 – Capital Outlay on Medical and Public Health – 04 Public Health – 200 Other Programmes – Externally Aided Projects – PD - Tamil Nadu Health System Reform Project Administrated by the Director of Public Health and Preventive Medicine – 416 Major Works – 01 – Major Works.

7. Necessary funds of Rs.1,00,00,000/- will be provided in Revised Estimate/ Final Modified Appropriation 2023–2024. Pending provision of such funds, the Director of Public Health and Preventive Medicine is authorized to draw and disburse the above sanctioned amount. However, this expenditure shall be brought to the notice of the Legislature by Specific Inclusion in the Supplementary Estimates 2023-2024. The Director of Public Health and Preventive Medicine is also requested to include this expenditure while sending the budget proposals for Revised Estimate/ Final Modified Appropriation 2023-2024 and also send draft explanatory notes for inclusion of this expenditure in the Supplementary Estimates 2023-2024 to Government in Finance (BG-I/Health-II) Department at an appropriate time without fail.
