ORDER:

The Hon'ble Minister for Health & Family Welfare has made the following Announcement in the floor of the Tamil Nadu Legislative Assembly during the Demand No. 19.

(Announcement No. 76):

“விபத்து மற்றும் காயப் பதிவேடு (TAEI Registry) ரூபாய் 1.56 கோடி செலவில் அனைத்து மருத்துவக் கல்லூரி மருத்துவ மனைகளில் விரிவுப்படுத்தப்படும்”.

2 Based on the above announcement, the Project Director, Tamil Nadu Health System Reform Program has sent proposal for Establishment of Trauma Registry at 11 New Medical College Hospitals and stated it is essential to have concrete data on the pre-hospital, hospital management and disposition of all trauma cases for analysis and improvement of trauma care services. During the year 2019-2020, as a part of first year activity, the trauma registry was developed and established in 2 centers (Government Vellore Medical College, Vellore and Government Hospital, Ambur) on a pilot basis using ODK format. During the year 2020-2021, as a part of second year activity, the trauma registry was established in 26 trauma care centers as per G.O.(Ms).No.519, Health and Family Welfare (EAPI-1) Department, Dated: 03.12.2020. As a next step towards this, it is contemplated that during the year 2021-22, the trauma registry shall be extended to the 11 new medical college hospitals.

3. The Project Director, Tamil Nadu Health System Reform Program has furnished the requirement for Establishment of Trauma Registry at 11 New Medical College Hospitals as detailed below:-

Qualification, Job Functions & Mode of Appointment For Trauma Registry Assistants (Staff Nurse):

Qualification:

He/ She should have completed Diploma / Degree in Nursing with Computer knowledge.

Job functions:

1. He/ She will collect and enter the relevant registry data from time of incidence, Pre hospital, in hospital course till disposal of the patient
2. He/ She will collate and analyze the data for the given indicators periodically in co-ordination with the State registry team
3. He/ She will also assist in nursing related work in Emergency Department.

Mode of Appointment:

Contract by the concerned Deans of the Institutions

4. The Project Director, Tamil Nadu Health System Reform Program has requested the Government to issue necessary orders in this regard.

5. The Government after careful consideration of the proposal of the Project Director, Tamil Nadu Health System Reform Program and have decided to accept with some restriction and accordingly issue the following orders:-

- i. Sanction is accorded for a sum of Rs.38,39,000/- (Rupees Thirty Eight Lakh and Thirty Nine Thousand only) to Director of Medical Education towards the establishment of Trauma Registry at 11 New Medical College Hospitals annexed to this Government Order as detailed below:

- ii. Sanction is accorded for two posts of Trauma Registry Assistants – (Staff Nurses) to each Medical College Hospital annexed to this G.O. (11X2 = 22 posts) as per qualification, job function and mode of appointment mentioned at para 3 above.
- iii. The Director of Medical Education is authorised to draw and disburse the above amount sanctioned in para 5(i) above.

6. The expenditure sanctioned in para 5(i) above shall be debited to the following head of account:-
