ORDER:

The Hon'ble Minister for Health and Family Welfare has made the following announcement (announcement No.41) on the floor of the Tamil Nadu Legislative Assembly during the Budget session.

"திருவள்ளூர் மாவட்டம்- விஜயபுரம் அரசு மகப்பேறு மற்றும் குழந்தைகள் நல மருத்துவமனைக்கு புதிய கட்டடம் ரூபாய் 6 கோடி மதிப்பீட்டில் அமைக்கப்படும்".

2. Based on the above, the Project Director, Tamil Nadu Health System Reform Program in the letter read above has sent a proposal wherein it has been stated that the State of Tamil Nadu is one among the few States to have achieved the Sustainable Development Goals (SDGs) in Maternal Mortality Rate (MMR) reduction. In order to improve the quality of care to the patient and to strengthen the obstetric and new born services in the hospitals, 'Comprehensive Emergency Obstetric and Neonatal Care' Centres were created in the year 2004. Comprehensive Emergency Obstetric and New born Care (CEmONC) centres were established throughout Tamil Nadu in phased manner, ensuring reduced travel by Antenatal or Labouring mother to reach an emergency obstetric health facility. The Comprehensive Emergency Obstetric and New born Care (CEmONC) centre are provided with additional infrastructure, Human Resources, Equipment and Blood Bank facilities which has resulted in reduction of Maternal and Infant Mortality rate. These centres are equipped with a fully functional Maternity Block, including a Labour ward, Operation Theatre, Blood Bank/Storage unit, New Born ward, New Born Intensive Care Unit (NICU) and Isolation ward.

3. Along with the additional particulars of General / ANC / Chief Minister's Comprehensive Health Insurance Scheme Performance, New Born Care and Ward admission, Human Resources details of the Institution, it is furnished the justification

to take up the activity. The construction plan for the above said activity is furnished as follows:-

4. The Project Director, Tamil Nadu Health System Reform Program has requested to sanction a non-recurring expenditure of Rs.6,00,00,000/- towards the construction of a Comprehensive Emergency Obstetric and New born Care (CEmONC) Government Women and Children Hospital, Vijayapuram, Tiruvarur District.

5. The Project Director, Tamil Nadu Health System Reform Program has further stated that out of Rs. 6,00,00,000/- , Rs.2,00,00,000/- is required for this year 2023-2024 and the remaining amount of Rs.4,00,00,000/- for next Financial year.

6. The State Empowered Committee has approved the above proposal.

7. After careful consideration of the proposal of the Project Director, Tamil Nadu Health System Reform Program, the Government have decided to accept the same and accordingly issue the following orders:-

- i. Administrative sanction is accorded for non-recurring expenditure of Rs.6,00,00,000/- (Rupees Six crore only) towards the construction of a Comprehensive Emergency Obstetric and New born Care (CEmONC) Government Women and Children Hospital, Vijayapuram, Tiruvarur District through Public Works Department (Medical Wing).
- ii. The Director of Medical and Rural Health Services is authorized to draw the amount sanctioned in 7(i) above.
- iii. The Director of Medical and Rural Health Services is directed to maintain a separate account exclusively for Tamil Nadu Health System Reform Program funds in Directorates, which should be operated by Joint Signatory.

8. The expenditure sanctioned in para 7 (i) above shall be debited to the following head of account:-

"4210 - Capital outlay on Medical and Public Health - 01 Urban Health Services - 200 - Other Health Schemes - Externally Aided Projects - PD - Tamil Nadu Health System Reforms Project - Administrated by the Director of Medical and Rural Health Services - 416 Major works - 01 Major works"
(DPC 4210 01 200 PD 41601)

9. Necessary funds of **Rs.2,00,00,000/-** will be provided in Revised Estimate/ Final Modified Appropriation 2023-2024. Pending provision of such funds, the Director of Medical and Rural Health Services is authorized to draw and disburse the above sanctioned amount. However, this expenditure shall be brought to the notice of the Legislature by Specific Inclusion in the Supplementary Estimates 2023-2024. The Director of Medical and Rural Health Services is also requested to include this expenditure while sending the budget proposals for Revised Estimate/ Final Modified Appropriation 2023 - 2024 and also send draft explanatory notes for inclusion of this expenditure in the Supplementary Estimates 2023-2024 to Government in Finance (BG-I/Health-II) Department at an appropriate time without fail.
