ORDER:

The Hon'ble Minister for Health and Family Welfare has made the following Announcement in the floor of the Tamil Nadu Legislative Assembly during the Demand No. 19.

(Announcement No. 75) :

“கர்ப்பகால பரிசோதனை பெட்டகம்” அரியலூர், இராமநாதபுரம் உள்ளிட்ட 10 முன்னுரிமை மாவட்டங்களில் உள்ள 2,249 துணை சுகாதார நிலையங்களுக்கு ரூபாய் 2.59 கோடி செலவில் வழங்கப்படும்”.

2. Based on the above announcement, the Project Director, Tamil Nadu Health System Reform Program has sent proposal approved by State Empowered Committee headed by Chief Secretary for Procurement of Ante natal Kit to 2249 Health Sub Centres in 10 Priority District.

3. The Project Director, Tamil Nadu Health System Reform Program has stated as follows:-

Based on the NFHS 4 result, the following districts have been identified as priority districts:

Full Antenatal Care as per World Bank:

1. Atleast 4 ANC visit
2. Atleast 1 TT Injection
3. IFA Tablet for 100 or more days

To reduce and to monitor the High-risk pregnancy, it is essential to screen the Ante Natal mother at first point of care facility (HSC) for which Ante Natal kit (Digital BP apparatus, Digital Weighing machine, Hand-held Foetal Doppler) may be provided to the 2249 HSCs of 10 priority districts by procuring through TNMSC. In fetoscope, Foetal Heart Rate could be detected only from 20 weeks onwards, but in Hand-held Foetal Doppler, the Foetal Heart Rate could be detected earlier from 12 weeks onwards. Therefore, early detection of Foetal Heart Rate is better through Foetal Doppler. Furthermore, Foetal Heart Rate could be heard by the mother, which gives the mother a sense of her baby's well-being.

7. The Government after careful consideration of the proposal of the Project Director, Tamil Nadu Health System Reform Program have decided to accept the same and accordingly issue the following orders:-

- Sanction is accorded for a sum of non-recurring expenditure of Rs.2,58,63,500/- (Rupees Two Crore, Fifty Eight Lakh, Sixty Three Thousand and Five Hundred only) to Director of Public Health and Preventive Medicine towards procurement of Digital BP apparatus, Digital weighing machine, hand held Foetal Doppler per Health Sub Canters for 2249 Health Sub Canters in 10 Priority District as annexed to this Government Order through Tamil Nadu Medical Service Corporation.

- ii) The Director of Public Health and Preventive Medicine is permitted to draw and utilize the above sanctioned amount. A separate account to be maintained exclusively for TNHSRP funds in Directorates, Districts and Facilities (till beneficiary level if needed) involved, which should be operated by Joint Signatory.
