OHCC Pilot districts

Selected the pilot area-Cuddalore and GCC

- 1. The Draft OHCC Action Plan for Cuddalore is ready for print.
- 2. The Draft OHCC Action Plan for Greater Chennai Corporation is ready for print.
- 3. Line-listed data for the period from November 2023 to October 2024 has been received from the Department of Public Health and Preventive Medicine for the pilot districts.
- 4. The comparison and analysis of the disease list provided by the Department of Public Health and Preventive Medicine are currently in progress, while similar data is being requested from the Department of Animal Husbandry.
- 5. The line-listed data from the Department of Animal Husbandry is expected to be received by January 2025 OHCC Disease Surveillance System.
- 6. The mapping outputs for the line-listed data of the pilot districts are expected within a few weeks from TNeGA, following the submission of cleaned data received from the respective departments.
- 7. A one-day training framework on One Health and Climate Change for health professionals has been prepared, and a training plan will be developed accordingly.

OHCC Disease Surveillance System

The dates for data collection from the identified sample collection spots in Cuddalore, Greater Chennai Corporation, and the respective converging departments are yet to be finalized. The process is currently in progress.
